

COMMITTEE ASSIGNMENT PREFERENCES DUE BY SEPTEMBER 7

All external partners are requested to participate in no fewer than two committees (1 Administrative and 1 Functional). With the exception of the Executive Committee, each Committee will be responsible for determining its own leadership. If your organization's representatives have not already signed up to participate in one of these Committees, please do so as soon as possible:

ADMINISTRATIVE COMMITTEES

Executive Committee

- Develop by-laws or operating guidelines
- Empowered to make final internal/admin decisions
- Set the strategic direction for the organization
- Create other committees or working groups as needed
- May have additional duties pending the final structure

Finance Committee

- Establish initial financial protocols for the organization
- Determine options for ensuring financial stability of the External Partners Group, working with the Nominations Membership Committee
- Ensure financial stability and viability of the organization
- Adherence to generally accepted accounting principles

Nominations & Membership Committee

- Establish membership benefits, application procedures, and other processes
- Recommend procedures for selection of the Executive Committee that will solicit nominations from the entire membership and result in balanced representation of members' interests
- Recruit new members to the External Partners Group

Communications Committee

- Assist staff with external and membership communications
- Provide visibility to activities and events organized by the External Partners Group

FUNCTIONAL COMMITTEES

Education/Advocacy Committee

- Work with CDC to plan, implement, and evaluate a national conference
- Coordinate additional events or forums to help implement various objectives and programs (and provide educational updates on various agency initiatives)
- Coordinate and implement a strategic plan for advocating for the priorities of the NCBDDD

Policy & Programs Committee

- Possible Subcommittees to include but not be limited to the following topical areas: Prevention, Research, Treatment, Surveillance
- All Subcommittees should be cross-sectional and include representation from a multitude of stakeholders with various/diverse interests


