



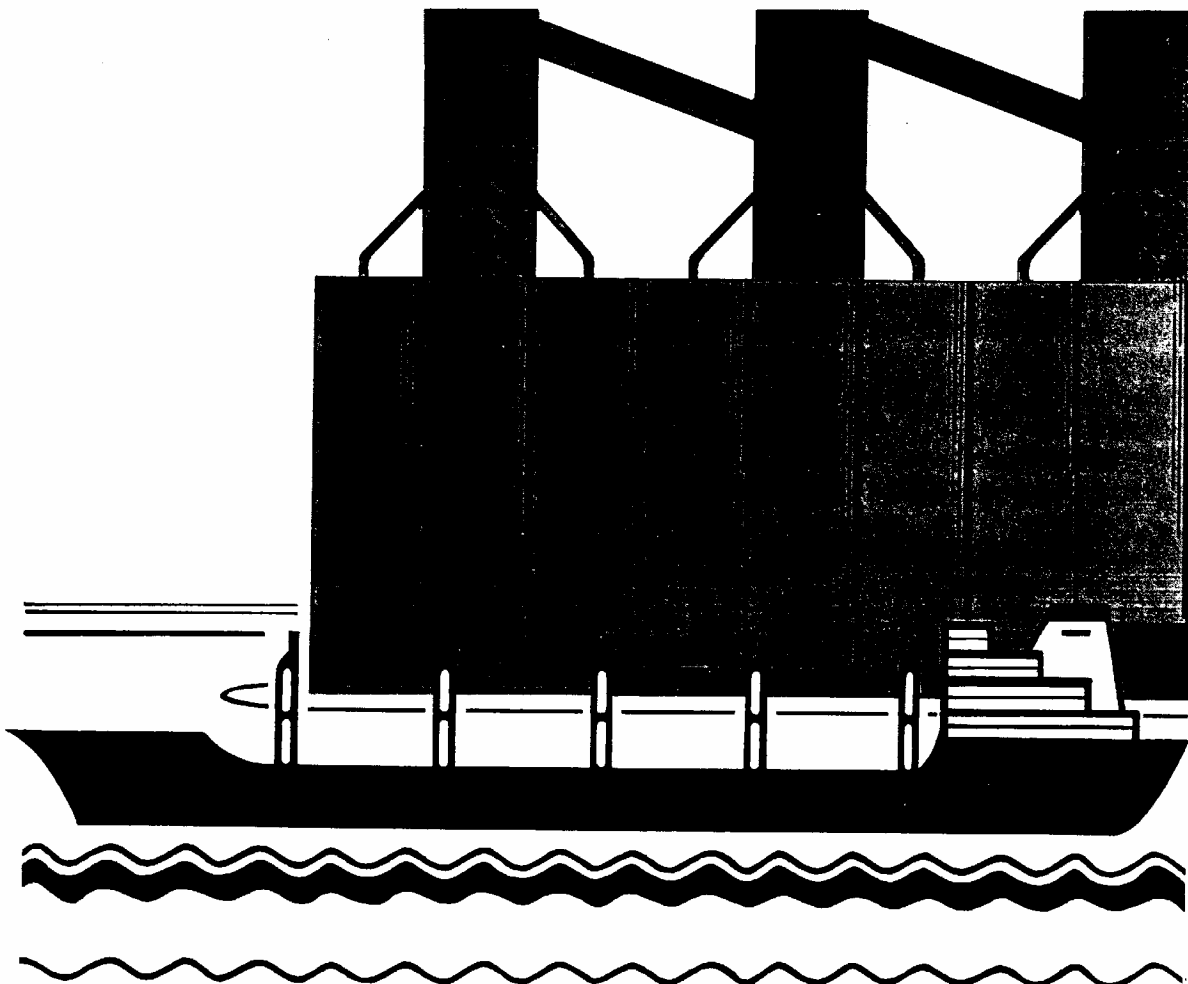

## REGISTRATION REQUIREMENTS

The United States Grain Standards Act (USGSA), 7 U.S.C. 87f-1, requires the registration of all persons engaged in the business of buying grain for sale in foreign commerce. In addition, those individuals who handle, weigh, or transport, grain for sale in foreign commerce must register. The statute also provides exemptions from these mandatory requirements for small grain exporters.

The USGSA regulations define foreign commerce grain business as persons who regularly engage in buying for sale, handling, weighing, or transporting grain totaling 15,000 metric tons or more during the preceding or current calendar year.
