## Holocaust-Era Assets A Finding Aid to Records at the National Archives at College Park, Maryland Greg Bradsher

Recent years have seen an explosion in the interest in locating and restoring gold, art, and other assets looted by the Nazis during the Holocaust or unclaimed by Holocaust victims. This aid to locating records at the National Archives at College Park focuses primarily on efforts to identify, recover, and restitute assets hidden or stolen by Nazi Germany during World War II. It also covers topics such as World War II economic warfare and provides a starting point for those interested in other aspects of the Holocaust era, including refugees and war crimes.

Included are descriptions of records relating to: Nazi-looted art and gold; U.S. efforts during 1944 and 1945 to prevent the Axis from secreting their assets in neutral countries ("The Safehaven Program"); the U.S. postwar role in locating and restituting looted assets; unpaid and unclaimed insurance policies; slave and forced labor; looted and misplaced libraries and archives; World War II economic warfare; and enemy and victim assets in the United States.

This comprehensive volume is an essential aid for individuals studying the World War II period in Europe and Latin America. An extensive bibliography of related materials is included.

# Guide to Records Relating to U.S. Military Participation in World War II Compiled by Timothy P. Mulligan

This series of guides identifies and describes the activities of the many military agencies that had a role in World War II. Although these materials emphasize the period December 1941 through September 1945, extensive documentation of the interwar and pre-Pearl Harbor periods is also included. Representing the activities of a broad range of agencies, these guides make accessible a large body of records for the first time.

## Part I: Policy Planning, Administration

Part I includes records that cover such topics as formulation of strategy; personnel matters associated with the war; financial matters, including acquisition of land for military installations; legislative issues; and mobilization and training of U.S. military and naval personnel.

#### Part II: Support and Supply

Part II identifies and describes records in the National Archives that document the activities of the many military agencies involved in armaments production and procurement, lend-lease, stockpiling and consumption of strategic and conventional industrial materials, shipbuilding, military construction, protection of the Western Hemisphere, logistical support, services furnished to personnel, surveys of soldier attitudes, and detention of POWs and civilian internees.

American Women and the U.S. Armed Forces A Guide to the Records of Military Agencies in the National Archives Relating to American Women

This important guide describes records in the National Archives and Presidential libraries that relate to American women who interacted with and eventually formed a part of the nation's military service organizations.

Covering the last two centuries, the records highlighted in this volume discuss women as participants in and victims of war, suppliers of military goods and services, and wives and mothers of soldiers. The documents include those of the armed services as well as the War Department collections of Revolutionary War and Confederate records. A comprehensive name and subject index and four appendixes are included. Researchers will find the guide an excellent starting point in the study of the role of the U.S. Government in the lives of American women.

## War & Conflict Selected Images from the National Archives, 1765–1970

Edited by Jonathan Heller

From the Revolutionary War through the Vietnam conflict, this handsome catalog presents over 1,500 arresting black-and-white images relating to American wartime history—selected from the 10 million images located in the National Archives Still Picture Branch. The book is divided into seven sections: the "Revolutionary War" (1775–83); "America Grows" (1799–1848); the "Civil War" (1861–65); "America and World Affairs" (1871–1970); "World War I" (1914–18); "World War II" (1939–45); and the "Korean War" (1950–53). Roughly 40 percent of the images—which include copies of prints, paintings, and posters as well as photographs—depict scenes from World War II. An introduction discusses the history of war photography and the National Archives still picture collection. An index of artists and photographers is also included.

# The Secrets War The Office of Strategic Services in World War II

Edited by George C. Chalou

This volume contains the proceedings of the first major scholarly conference on the Office of Strategic Services (OSS), which was held at the National Archives Building on July 11 and 12, 1991—exactly 50 years after President Franklin D. Roosevelt appointed William J. Donovan Coordinator of Information. Donovan continued to head the organization when it was renamed the Office of Strategic Services in 1942. Through the war years the OSS served the intelligence needs of the United States. It was terminated by order of President Harry S. Truman in the fall of 1945.

These 24 papers—presented at the conference by veterans and historians of the OSS—offer new insights into the activities and importance of the United States first modern national intelligence agency. The first of eight sections discusses the United States on the brink of war. The following six cover the operations of the OSS at the headquarters level and in the field throughout Western Europe, the Balkans, and Asia. The final chapter explores the legacy of the OSS. Contributors include Arthur Schlesinger; William Colby; Aline, Countess of Romanones; Walt W. Rostow; and Robin Winks.
