HISTORY



A 1961 Executive Letter, signed by President John F. Kennedy, established Federal Executive Boards (FEB's). FEB's were established to bring the Federal Government closer to the people we serve, be more responsive to local issues, and serve as a conduit of information directly from the Executive Office of the President to Federal entities located outside of Washington, DC. The Cleveland FEB was established in 1966.

COMPOSITION

Similar to the President's Cabinet in our Nation's Capital, FEB membership becomes automatic and mandatory by virtue of the incumbent being the senior agency official within the FEB's geographic boundaries. Unlike the Cabinet, membership is not limited to department-level organizations. The "Cleveland Cabinet" consists of the highest-ranking Federal leaders from approximately 85 Federal agencies located in the Cleveland area.

STAFF



A two-person staff carries out the day-to-day operations of the Cleveland Federal Executive Board. They report directly to the Policy Committee and provide oversight to the committees of the board focusing on the goals and objectives of the FEB Strategic Plan. They serve as ambassadors for the Federal community and act as principal liaisons with key Federal, state, local, and community officials for the positive development of effective intergovernmental relations and partnerships.

CREATE PARTNERSHIPS WITHIN OUR COMMUNITIES

Graduated the fifth class of the Cleveland Federal Community Leadership Institute (CFCLI), which consisted of 22 individuals representing 10 agencies. The program provides local, low-cost intergovernmental training and mentoring for Federal employees identified by their agency as having leadership potential. The mission of the CFCLI is to identify and develop leaders committed to advancing greater cooperation among Federal agencies and to strengthening community partnerships. Their goals are

- ◆ To assist Federal agencies in the professional development of leaders
- To understand and develop community partnerships
- To enhance individual leadership skills

Partnered with Business Volunteerism Council (BVC) to make a presentation to the fifth annual CFCLI. Yearly, BVC assists our CFCLI in developing and implementing strategy for community involvement to benefit the Federal government, CFCLI participants, and the community. The 22 CFCLI participants were invited to participate in the BVC's board training and referral program, the Volunteer Trustee Institute. Through the program, CFCLI participants will serve on various boards.

Hosted the FEB's Year 2001 Distinguished Federal Service Recognition Awards Program during Public Service Recognition Week held each year during the first week of May. Approximately 625 people attended the awards luncheon to honor 69 Federal workers from 21 agencies. The host agency was the John H. Glenn Research Center at Lewis Field, led by Donald J. Campbell, Director. Karen Hickman, NASA, served as Project Manager. Posters were used to promote the recipients and were distributed throughout the entire Federal community.

Published and distributed Emergency Phone Number Card that was created by the Emergency Preparedness Committee. The card is intended to be carried by employees to provide ready access to many telephone numbers that should prove useful in an emergency.

Published and distributed the Employee Emergency Contingency Handbook that was created by the Emergency Preparedness Committee. The handbook outlines several important areas that every employee should be ready to respond.

Published and distributed Cleveland 2001 Directory of Federal Agencies and Departments— Federal agency contacts in the Cleveland area including addresses, phone numbers, Internet addresses, and the mission statement. The directory was provided to Federal agencies.

IMPROVE INTERGOVERNMENTAL PARTNERSHIPS



Published and distributed the Interagency Mediation Group (IMG) Handbook and Brochure. IMG provides mediation as an alternative to resolve workplace disputes within Federal agencies.

Sponsored Congresswoman Stephanie Tubbs Jones and the Cleveland Federal Executive Board Alternative Dispute Resolution (ADR) Committee Kickoff Event for the IMG. At the kickoff, over 200 employees were introduced to the ADR program newly available to the Cleveland Federal community and had the opportunity to meet members of the ADR Committee and several mediators.



The program has available 31 mediators who are experienced in resolving Federal workplace disputes at early stages. They have completed special mediation training designed and implemented by the Federal Mediation and Conciliation Service to meet local needs.

Worked with the Department of Treasury Savings Bond Marketing Office to increase awareness of the annual Savings Bond Campaign. Attended the kickoff luncheon.

During open season, in partnership with GSA and VAMC, the FEB sponsored a Health Benefits Fair at the Anthony J. Celebrezze Federal Building. This fair was open to all local Federal employees and retirees. Various health insurance providers were on hand to discuss their services. The Veterans Administration Medical Center provided health screening to veterans.



Sponsored a Financial Planning and Retirement Seminar, which was provided by the NASA Glenn Research Center. Over 120 Federal employees from various agencies attended.

Sponsored a Cleveland Municipal School District presentation, which was presented by Reverend Hilton O. Smith, Chair, Board of

Education. His topic was "The Education of Children Is Our Future." There were 49 Federal employees in attendance.



Sponsored the Document Automation and Production Service (DAPS) Initiative presentation. Armed with more than 50 years of experience, DAPS continually harnesses the newest automation technologies to deliver innovation and efficiency.

Sponsored a Federal Brownfield One-Stop Shop (BOSS) Committee update. The BOSS Initiative provides an opportunity for Federal agencies to work together in a more integrated fashion toward sustainable redevelopment.

ADVANCED LOCAL AND NATIONAL INITIATIVES

Partnered with the Martin Luther King, Jr., (MLK) Law and Public Service High School. This school is located in the Hough neighborhood, which is severely socio-economically disadvantaged and in an Empowerment Zone. Our participation includes the annual fair, which is designed to accomplish at least two things. First, it exposes the students to the world of career possibilities they have available to them as they seek employment, and second, it allows prospective employers—representing local Federal government agencies—to meet and become aware of the qualified students at MLK High School. Representatives from 17 Federal government agencies participated.

Partnered with local colleges and universities to sponsor a Federal employee college fair. Counselors from 16 leading area colleges and universities were available to meet with individuals interested in earning undergraduate and graduate degrees.

The Northeast Ohio Combined Federal Campaign (CFC) raised \$1,831,992 during the 2000 campaign. This is a 5.4 percent increase over dollars raised in 1999 (\$1,738,304). The participation rate also rose to 50 percent. The overall per capita increased from \$80.80 to \$97.05 and the average gift increased from \$184 to \$194. This is also the fourth consecutive year of growth for the CFC. The theme for the campaign was "Facing Tomorrow . . . A Look Into the Future."

Benefited homeless individuals in Cleveland by collecting various individual personal hygiene items such as soap, shampoo, conditioner, lotion, etc., from hotels and motels. Approximately 600 persons utilized items.

Coordinated the annual Harvest for the Hunger Food Drive. This year 25 agencies participated in raising 25,150 pounds of food succeeding last year's 20,368 pounds. Each 2 pounds of food provided two meals to hungry persons in the Cleveland community.

Partnered with the Cleveland Browns in their commitment to improving the quality of life in the Greater Cleveland community. Alongside the American Red Cross and the American Sickle Cell Anemia Association, created a taskforce to increase summer blood donations (149) and new minority blood donors (29) so that donor matches can be identified for local children with sickle cell anemia. In addition, arranged for six blood drives. Cleveland Federal workers donated 1104 pints of blood. This helped to save over 3312 lives. The Federal Government continued to be in the top three organizations in Northeast Ohio for having the most blood donors.

Partnered with the Mandel School of Applied Social Sciences and Case Western Reserve University to participate in the "Alumni/Student Match Program."

Partnered with the Mandel Center for Nonprofit Organizations and Case Western Reserve University for a unique new initiative called Mandel Center Leaders' Link. Executive Director Judy Montfort will serve as a group facilitator.

Partnered with Office of Personnel Managements New Leader Program to mentor David P. Condon, Defense Financing and Accounting Service. He was able to experience numerous leadership skills during his 30-day detail.

In an effort to furnish information to middle school teachers using available Federal resources, the FEB gathered information from Federal agencies. The information will be published in a booklet and distributed to Cleveland municipal middle schools. This is a different approach to the national initiative of "After-School." The booklet targets services, websites, classroom speakers, and other government resources to enhance the curriculum and/or learning experience of students.

Collected over 2000 used eyeglasses from various Federal agencies and donated them to the Cleveland Sight Center. The collected glasses were sent to an ophthalmology school in Columbus where the students test the lenses for strength and make any necessary repairs. Every part of the old glasses is used. Frames with no lenses, lenses with no frames, even eyeglass cases were collected. Doctors then take these eyeglasses to clinics in Third World countries where they are given free to those in need.

SUMMARY OF SIGNIFICANT ACCOMPLISHMENTS DURING 2001

A new class of 22 students representing 10 agencies was enrolled in FEB's Cleveland Federal Community Leadership Institute for FY 2001.

Congresswoman Stephanie Tubbs-Jones spoke on June 11, 2001, to Federal employees about mediation and a new program being launched in the Cleveland area. This program, Interagency Mediation Group (IMG), encourages resolution of workplace disputes. The IMG kicked off its new program on that Monday from 11:50 a.m to 1:00 p.m. at the Anthony J. Celebrezze Federal Building, 31st floor auditorium. Comer Cash, Vice President of the National Alliance of Postal and Federal Employees, also spoke relating his experiences with mediation. Mediation is an informal, confidential process that uses trained neutrals to

help people resolve disputes in a way that is acceptable to both sides. It is an effective means to settle disagreements and avoid litigation. It also improves productivity, fosters better communication, and cuts the cost of workplace disputes. The IMG is one of a new breed of "shared neutrals" programs gaining popularity with Federal agencies around the country. Through such programs, Federal agencies loan mediators, at no charge, to other Federal agencies to help resolve workplace disputes. The program is sponsored and managed by the Cleveland Federal Executive Board. An IMG handbook and a brochure were published.

The Cleveland Federal Executive Board, the Cleveland Browns, American Sickle Cell Anemia Association, American Red Cross, and 481 blood donors came together in a show of support at the Dr. Charles Drew Blood Drive on July 21st at Cleveland Browns Stadium. The goal of the drive was to increase the number of summer blood donations (149), sign on new minority donors (29), and identify donor matches for local children with sickle cell anemia—a disease that affects minority populations. Of the 80,000 Americans with the genetic disease, 90 percent are of African descent. One in every 375 African-American newborns has sickle cell disease. Hispanic patients comprise the remaining 10 percent. Those born with the disease cannot outgrow it. They suffer acute pain and can experience serious problems, including jaundice, strokes, severe anemia, serious infections, and damage to the lungs, kidneys, and spleen. Over half of the patients fighting sickle cell disease require blood transfusions during their lifetime. The majority requires more than one, and patients with severe cases can require blood transfusions every 4 weeks. Potentially, a child could use more than 600 pints of blood between the ages of 3 and 19. To ensure that a child's body does not begin to reject needed blood transfusions, blood must be matched by type—A, B, AB, and O positive and negative—and by protein components called antigens. In some rare cases, it can take up to 30,000 donors before a match is found for a child.
