Internet Explorer 5.5 or 6.0 only.

(Hint: To determine which version of Internet Explorer you have,

open Internet Explorer and select: Help -> About Internet Explorer.

If the "**Version**" field is below 5.5, you can run IE 6.0 setup program (ie6setup.exe) to upgrade your browser to Internet Explorer 6.0.

Internet Connection: You will need a **high-speed Internet connection** for this meeting.

Registration Instructions:

- Open Internet Explorer Internet Explorer and type https://epastx.epa.gov in the address bar Address in https://epastx.epa.gov and press the Enter key.
 Note: If the Security Alert Security Alert window appears, press Yes Yes Yes
- 2. Press the **New Extranet User Registration button** New Extranet User Registration to create a username and password.

3. In the section, choose what you want to do, click the text: "Extranet users only - request a new account".

4. Complete the following fields:
