## NOTICE OF SEPTEMBER 5, 2001 DEADLINE FOR FILING PROOFS OF CLAIM

# TO ALL PERSONS AND ENTITIES WITH CLAIMS AGAINST PACIFIC GAS AND ELECTRIC COMPANY ("PG&E"):

PLEASE TAKE NOTICE that on June 14, 2001, the United States Bankruptcy Court for the Northern District of California (the "Bankruptcy Court") entered a Revised Case Management Order in the above-captioned Chapter 11 case which, among other things, repeated that <u>September 5, 2001</u> has been established as the general claims bar date (the "Claims Bar Date") in the Chapter 11 bankruptcy case of PG&E.

#### 1. WHO MUST FILE A PROOF OF CLAIM

If you have a claim against PG&E that arose prior to April 6, 2001 (the date PG&E filed its bankruptcy petition) but you are not listed in PG&E's Amended and Restated Schedules filed in the above-referenced bankruptcy case on July 2, 2001 (as amended and restated, the "Schedules"), or your claim is listed as "disputed," "contingent" or "unliquidated" in the Schedules, then you must file a Proof of Claim or you might not be paid any money on your claim against PG&E in this Chapter 11 case. If your claim is scheduled, and is not listed as disputed, contingent or unliquidated, it will be allowed in the amount scheduled unless you file a Proof of Claim or you are sent further notice about the claim. The enclosed Proof of Claim form states whether your claim is listed in the Schedules and, if so, the amount of such claim and whether it is listed as disputed, contingent or unliquidated. Whether or not your claim is scheduled, you are permitted to file a Proof of Claim.

## 2. WHO IS <u>NOT</u> REQUIRED TO FILE A PROOF OF CLAIM:

You are <u>not</u> required to file a Proof of Claim if:

- A. You do not dispute the amount or classification of your claim as stated on the enclosed Proof of Claim form or as set forth in the Schedules, and your claim is not listed as "contingent," "unliquidated" or "disputed;"
- B. You have already properly filed, with the Noticing Agent as set forth in Section 4 below, a Proof of Claim against PG&E;
- C. You hold a claim that has been allowed or paid pursuant to an order of the Bankruptcy Court entered on or before the Claims Bar Date; or
- D. You have a claim allowable under 11 U.S.C. § 507(a)(1) as an administrative expense claim.

YOU DO NOT NEED TO FILE A PROOF OF CLAIM IF YOU DO NOT HAVE A CLAIM AGAINST PG&E, OR IF ANY CLAIM YOU HELD ON APRIL 6, 2001 HAS BEEN PAID.

### 3. RESERVATION OF RIGHTS

PG&E expressly reserves the right to: (1) dispute, object to or assert offsets or defenses against any filed Proof of Claim or any claim listed or reflected in the Schedules, with respect to the WD 070201/1-1419903/921115/v10

nature, amount, liability, classification or otherwise, of any such filed Proof of Claim or claim; or (2) subsequently designate any claim as disputed, contingent or unliquidated. Nothing set forth in this Notice shall preclude PG&E from objecting to any claim or Proof of Claim, whether scheduled or filed, on any grounds.

## 4. WHEN AND WHERE TO FILE PROOFS OF CLAIM

Except as otherwise provided herein, a signed original and one copy of any Proof of Claim, together with any accompanying documentation, must be delivered by mail, hand delivery or overnight courier, so as to be received no later than 5:00 p.m., Pacific time, on September 5, 2001, by Robert L. Proofs of Claim will be deemed filed only when actually received at the address listed above. If you wish to receive a "file-stamped" copy of your Proof of Claim, you should enclose an extra copy of your Proof of Claim and a stamped, self-address envelope.
