#### SETTLEMENT AGREEMENT

This Settlement Agreement ("Agreement") is made by and between L. John Iani,
Regional Administrator for the United States Environmental Protection Agency Region X,
Christine Todd Whitman, Administrator of the United States Environmental Protection Agency,
and the United States Environmental Protection Agency (collectively, "EPA"), the Idaho
Conservation League and The Lands Council (collectively, "Plaintiffs"), and the Idaho
Department of Environmental Quality ("DEQ" or "State" or "Idaho").

WHEREAS, Plaintiffs filed and served the Complaint in Civ. No. C00-972 Z (W.D. Wash.) ("the Litigation") on June 6, 2000, seeking declaratory and injunctive relief based on allegations that EPA failed to undertake what Plaintiffs allege to be nondiscretionary duties imposed by section 303(d) of the Clean Water Act ("CWA"), 33 U.S.C. § 1313(d). Plaintiffs allege that EPA has failed to comply with CWA § 303(d), which relates to the establishment of Total Maximum Daily Loads ("TMDLs") for water quality limited segments identified pursuant to the CWA, for the State of Idaho;

WHEREAS, pursuant to a stipulation entered into between Plaintiffs and EPA and filed with the Court in the Litigation, EPA and Idaho issued TMDLs for certain segments and pollutants, or "waterbody/pollutant combinations," within the Coeur d'Alene subbasin and the Court dismissed with prejudice Plaintiffs' claims related to the establishment of the TMDLs for certain waterbody/pollutant combinations within the Coeur d'Alene subbasin;

WHEREAS, as a result of prior litigation, *Idaho Sportsman's Coalition v. Browner*, Civ. No. C93-943WD (W.D. Wash.1997), a schedule for the development of TMDLs for all water quality limited segments on the State's 1996 § 303(d) list was agreed upon by the parties and

submitted to the court. This schedule, dated April 3, 1997, calls for all such TMDLs to be completed by DEQ in an 8-year time period ending in the year 2005;

WHEREAS, EPA and DEQ have developed a new schedule for the development of TMDLs for all waterbody/pollutant combinations on the State's 1998 § 303(d) list ("the Schedule"), which is attached hereto as Attachment 1;

WHEREAS, DEQ submitted to EPA a 1998 § 303(d) list that identified certain waterbody/pollutant combinations that had not been included in the State's 1996 § 303(d) list and did not identify certain other waterbody/pollutant combinations that had been identified in the 1996 § 303(d) list;

WHEREAS, on May 1, 2000, EPA approved DEQ's decision to include the waterbody/pollutant combinations identified on DEQ's 1998 submission, but disapproved DEQ's decision not to identify certain other waterbody/pollutant combinations on DEQ's 1998 submission;

WHEREAS, on January 29, 2001, EPA identified 127 waterbody/pollutant combinations to be added to the State's 1998 § 303(d) list;

WHEREAS, the Schedule attached hereto as Attachment 1 addresses all of the waterbody /pollutant combinations on the State's 1998 § 303(d) list, including those added as a result of EPA's action on January 29, 2001;

WHEREAS, DEQ utilized the document entitled "Water Body Assessment Guidance" ("WBAG") both as a guide to assist the State in the development of DEQ's 1998 § 303(d) list and to propose mid-cycle listing/delisting decisions;

WHEREAS, DEQ has developed a new guidance document to assist DEQ in determining which waterbody/pollutant combinations to include on future § 303(d) lists, which new guidance

supersedes WBAG and is hereinafter referred to as Waterbody Assessment Guidance II, or "WBAG II";

WHEREAS, it has been DEQ's practice to develop a subbasin assessment ("SBA") prior to the development of TMDLs for waterbody/pollutant combinations on Idaho's § 303(d) list. The SBA describes water quality in a subbasin, identifies and evaluates pollutant sources and activities that contribute to water quality problems, and identifies those waterbody/pollutant combinations in the subbasin that still require TMDLs;

WHEREAS, as a result of the SBA process, Idaho believes that the waterbody/pollutant combinations from the 1998 § 303(d) list that are set forth on Attachment 2 hereto do not require TMDLs;

WHEREAS, Idaho has preliminarily determined to propose delisting the waterbody/pollutant combinations set forth on Attachment 2 based upon an analysis done in accordance with the WBAG and a review of other available, relevant data;

WHEREAS, on July 13, 2000, EPA published a final rule addressing TMDLs entitled "Revisions to the Water Quality Planning and Management Regulation and Revisions to the National Pollutant Discharge Elimination System Program in Support of Revisions to the Water Quality Planning and Management Regulation," 65 Fed. Reg. 43585 (July 13, 2000) ("Revisions Rule");

WHEREAS, the Revisions Rule is not in effect, <u>see</u> 66 Fed. Reg. 53044 (October 18, 2001), but the parties recognize that, if and when it takes effect, the Revisions Rule might affect DEQ's performance and obligations under this Agreement;

WHEREAS, on September 4, 2001, the state district court in ASARCO, Inc. v. State of Idaho, Department of Environmental Quality, Case No. CV-00-05760, issued a Memorandum

Opinion and Order in which the court invalidated the South Fork Coeur d'Alene River TMDL ("SFCDA decision");

WHEREAS, DEQ has appealed the SFCDA decision but that appeal has not yet been resolved;

WHEREAS, Plaintiffs, EPA and DEQ have agreed to this Settlement Agreement without any admission of fact or law in order to achieve as rapidly as possible the establishment of sound and defensible TMDLs for the State of Idaho;

WHEREAS, by entering into this Settlement Agreement, plaintiffs do not waive, release or settle any claims or challenges they may now have, or may have in the future, to the substance of any TMDLs, the listing or delisting of any waterbody/pollutant combinations from DEQ's § 303(d) list or the application of WBAG or WBAG II;

WHEREAS, Plaintiffs, EPA and DEQ consider this Agreement to be a fair, adequate and equitable resolution of the claims that were or potentially could have been raised in the litigation;

WHEREAS, by entering into this Settlement Agreement, EPA and DEQ do not waive or limit any claim or defense, on any grounds, related to any final agency action taken pursuant to this Agreement, including the approval, disapproval and/or development of CWA § 303(d) lists and/or the establishment of TMDLs in Idaho;

WHEREAS, DEQ has provided notice to the public of, and has solicited and reviewed comments on, this Settlement Agreement;

WHEREAS, Plaintiffs, EPA and DEQ believe it is in the interest of the public, the parties and judicial economy to resolve the issues in this action without protracted litigation;

NOW, THEREFORE, PLAINTIFFS, EPA AND DEQ AGREE AS FOLLOWS:

### I. Parties Bound.

This Settlement Agreement applies to, is binding upon and inures to the benefit of Plaintiffs (and their successors, assigns and designees), EPA and DEQ.

#### II. Definitions.

Unless otherwise expressly provided, terms used in this Settlement Agreement that are defined in the CWA or in implementing regulations shall have the meaning assigned to them therein as of the date that this Agreement is executed by all parties or as subsequently amended. For the purposes of this Settlement Agreement, the following terms shall have the meaning provided below:

- A. "DEQ" means the Department of Environmental Quality for the State of Idaho.
- B. "EPA" means the United States Environmental Protection Agency, including
  L. John Iani, Regional Administrator for the United States Environmental
  Protection Agency Region X, Christine Todd Whitman, Administrator of the
  United States Environmental Protection Agency, and their successors.
- C. "Execution" means the signing of an original counterpart to this Agreement.
- D. "Final Action By DEQ" means submission of TMDLs by DEQ for EPA's approval or disapproval.
- E. "The Litigation" means Civ. No. C00-972 Z (W.D. Wash.).
- F. "1997 Schedule" means the schedule for the development of TMDLs for all water quality limited segments on the State's 1996 § 303(d) list that was agreed

- upon and submitted to the court in *Idaho Sportsman's Coalition v. Browner*, Civ. No. C93-943WD (W.D. Wash. 1997).
- G. "1998 Section 303(d) list" means the list submitted by DEQ to EPA that EPA approved on May 1, 2000 as well as the 127 waterbody/pollutant combinations added by EPA on January 29, 2001;
- H. "Parties" means the Idaho Conservation League, The Lands Council, EPA and DEQ.
- I. "Plaintiffs" means the Idaho Conservation League and The Lands Council.
- J. "Section 303(d) list" means the list required by Section 303(d)(2) of the CWA, 33 U.S.C. § 1313(d)(2), and 40 C.F.R. § 130.7(d), to be submitted to EPA.
- K. "Schedule" means the schedule for the submission of TMDLs by DEQ that is attached hereto as Attachment 1 or as subsequently amended pursuant to the terms of this Agreement.
- L. "Total Maximum Daily Loads" or "TMDLs" has the meaning provided at 40 C.F.R. § 130.2(i), as of the date of execution of this Agreement or as subsequently amended.
- M. "United States" means the United States of America, including its officers, agencies, departments and instrumentalities.
- N. "Water Quality Limited Segments" or "WQLSs" has the meaning provided at 40 C.F.R. § 130.2(j), as of the date of execution of this Agreement or as subsequently amended.

- O. "Waterbody Assessment Guidance" or "WBAG" means the guidance document that DEQ used in developing the Section 303(d) list that it submitted to EPA in 1998 and has also used to propose mid-cycle delisting decisions.
- P. "Waterbody Assessment Guidance II" or "WBAG II" means the guidance document, the draft of which was proposed on January 30, 2001, that the State has developed to assist the State in determining which waterbody/pollutant combinations to include on future § 303(d) lists and in reevaluating for potential delisting certain waterbody/pollutant combinations on the 1998 Section 303(d) list.
- Q. "Water Quality Standards" has the meaning provided at 40 C.F.R. § 130.2(d), as of the date of execution of this Agreement or as subsequently amended.

### III. The TMDL Schedule.

- A. The parties have agreed to a Schedule that includes dates for Final Action By DEQ on the TMDLs for the WQLSs identified on the 1998 Section 303(d) list (subject to Paragraph III.B and Section IV below, relating to TMDLs DEQ need not complete and to modification of the Schedule). The Schedule is set forth as Attachment 1 hereto, the terms of which are incorporated by reference in this Settlement Agreement. The parties agree that the Schedule, including the overall time-frame and the order in which TMDLs are to be developed, as well as the provisions in this Agreement that allow future changes to the Schedule, are reasonable. The parties agree that this Schedule replaces the 1997 Schedule and that the 1997 Schedule is null and void.
- B. In fulfilling its commitments under this Settlement Agreement, DEQ is under no obligation to establish a TMDL for any waterbody/pollutant combination for a WQLS listed on

the Schedule for which EPA approves a decision by DEQ to delist the waterbody/pollutant combination under CWA section 303(d). In addition, DEQ is not responsible for, and is under no obligation to establish, TMDLs for any waterbody/pollutant combinations for any WQLSs listed on the Schedule for which DEQ does not have jurisdiction to establish a TMDL. Nothing in this Settlement Agreement shall be deemed to recognize, imply or confer State authority or jurisdiction under the CWA over any Indian country, as defined at 18 U.S.C. § 1511.

- C. DEQ and the Plaintiffs agree that all TMDLs submitted to EPA for approval and/or disapproval after the date of execution of this Settlement Agreement shall include as an attachment a summary of implementation strategies. EPA, DEQ and the Plaintiffs understand, however, that EPA will approve or disapprove only the TMDL as defined by 40 C.F.R. § 130.2(i) and that, pursuant to regulations in effect at the time this Agreement is executed, EPA will not approve or disapprove the attached summary of implementation strategies. Further, EPA, DEQ and the Plaintiffs understand that the presence or absence of a summary of implementation strategies will not be a factor in EPA's decision to approve or disapprove the TMDL. DEQ and the Plaintiffs agree that the summary of implementation strategies shall include:
  - 1. The expected timeframe for meeting water quality standards;
  - 2. The approaches to be used to meet load and wasteload allocations;
- 3. An identification of the federal, state and local governments, individuals or entitites that will be involved in or responsible for implementing the TMDL; and
- 4. A monitoring strategy to measure implementation activities and achievement of water quality standards.

DEQ recognizes that implementation strategies for TMDLs may need to be modified if monitoring shows that the TMDL goals are not being met or significant progress is not being made toward achieving the goals.

## IV. Future Modifications of the Schedule.

A. The parties understand that the Schedule is based on the 1998 Section 303(d) list and that future Section 303(d) lists may include waterbody/pollutant combinations that may warrant TMDL development prior to waterbody/pollutant combinations for WQLSs listed on the Schedule. The parties agree that the State may substitute one or more such future-listed waterbody/pollutant combinations for one or more waterbody/pollutant combinations for WQLSs on the Schedule. No such substitution will affect the overall pace of the 10-year time frame for completing the TMDLs in the Schedule.

- B. The sequencing of TMDL development reflected in the Schedule is premised upon existing information regarding severity of pollution and uses of the waters, existing priorities and resources, and coordination with activities of other state and federal agencies. DEQ may change the sequencing of TMDL development in the Schedule if new information is collected or if issues arise that: (1) affect state or federal priorities; (2) indicate more time is needed to complete a TMDL; or (3) suggest it would be more appropriate to develop a TMDL at an earlier or later date. DEQ also may change the sequencing of TMDL development in the Schedule to reflect changes in agency resources available to complete development of TMDLs. No such change will affect the overall pace of the 10-year time-frame for completing the TMDLs in the Schedule.
- C. Prior to changing the Schedule under paragraphs IV.A or IV.B, DEQ shall provide notice to the applicable Basin Advisory Group ("BAG"), the Plaintiffs and other interested parties. This notice may be combined with or be a part of a public notice relating to the results

of a SBA and the development of TMDLs, or it may be provided by mailing the notice to the BAG, Plaintiffs and other interested parties. DEQ will consider comments received within 30 days of the notice and will consult with EPA prior to changing the Schedule under paragraphs IV.A or IV.B.

- D. The parties recognize that DEQ must submit delisting decisions to EPA for approval or disapproval, and that some of those submissions may occur "mid-cycle," i.e., prior to the date DEQ's next § 303(d) list is required to be submitted to EPA. For any such submissions by DEQ, including "mid-cycle" submissions:
- 1. DEQ shall publish notice to the public that: (a) specifically identifies the waterbody/pollutant combinations DEQ proposes to delist; (b) includes a brief description of the reasons for the delisting; (c) describes the location of any material available for public review supporting the delisting; and (d) explains that the public may provide comments regarding the proposed delisting for a minimum of 30 days. This notice may be combined with or be a part of a public notice relating to the results of the SBA and the development of TMDLs for the applicable subbasin.
- 2. DEQ shall decide whether to seek EPA approval for delisting any such waterbody/pollutant combinations after reviewing the comments regarding the proposed delisting(s). For those waterbody/pollutant combinations for which DEQ decides not to seek EPA approval for delisting, including any such waterbody/pollutant combinations on Attachment 2, DEQ shall publish notice to the public of that decision, and Final Action By DEQ on those waterbody/pollutant combinations shall be taken within one year of the date that DEQ publishes notice to the public of its decision not to seek approval for delisting. Final Action By DEQ shall be taken on any waterbody/pollutant combinations that DEQ submits to EPA for delisting

but for which EPA disapproves the delisting, including any waterbody/pollutant combinations on Attachment 2 that EPA disapproves for delisting, within one year of the date that EPA identifies that waterbody/pollutant combination as being part of Idaho's Section 303(d) list.

3. For those years that DEQ is required to submit a Section 303(d) list to EPA for approval, DEQ shall submit for EPA approval all of DEQ's delisting decisions from the previous calendar year as part of DEQ's Section 303(d) list. For those years that DEQ is not required to submit a Section 303(d) list to EPA for approval, DEQ shall, by April 1, submit for EPA approval all of DEQ's delisting decisions from the previous year in one package, accompanied by explanations of the basis for DEQ's decisions consistent with the requirements of 40 C.F.R. § 130.7(b)(6).

### V. Progress Reports and Documentation.

- A. DEQ shall provide Plaintiffs with a progress report by January 30 of every year after execution of this Agreement until completion of the Schedule. That report shall identify the following:
  - (1) the TMDLs submitted by the State during the preceding calendar year, the date of each submission, EPA action taken on each submission and the date of the action taken by EPA;
  - (2) any TMDLs that EPA has established during the preceding calendar year;
  - (3) all waterbody/pollutant combinations for WQLSs on the Schedule for which EPA has approved or disapproved a delisting during the preceding calendar year;
  - (4) an addendum to the Schedule that reflects all changes to the Schedule that occur after execution of this Agreement and that identifies the calendar year in which each change was made. The addendum shall include new dates, if any, by

which TMDLs for specific waterbody/pollutant combinations will be developed.

The addendum also shall cumulatively identify all waterbody/pollutant combinations for WQLSs on the Schedule for which EPA has approved a delisting after execution of this Agreement.

- B. EPA agrees to provide Plaintiffs with copies of the TMDLs and EPA letters approving the TMDLs for waterbody/pollutant combinations established by DEQ in accordance with this Settlement Agreement within a reasonable time after EPA approval of such TMDLs.
- VI. Use of WBAG II to Reevaluate Waterbody/Pollutant Combinations that DEQ Believes Should be Removed From the 1998 § 303(d) List.
- A. DEQ shall use the final WBAG II to reevaluate DEQ's preliminary determination to delist the waterbody/pollutant combinations from the 1998 § 303(d) list that are set forth on Attachment 2 hereto. The result of this reevaluation will be reflected in DEQ's 2002 § 303(d) list.
- B. DEQ shall use the final WBAG II to reevaluate the waterbodies set forth in Attachment 3, which sets forth sixty-four (64) waterbodies that were identified on the State's 1996 Section 303(d) list but did not appear on the 1998 § 303(d) list. DEQ collected new data for 53 of the 64 waterbodies set forth on Attachment 3 during the 2001 field season. The results of each reevaluation shall be reflected in the listing decision submitted by DEQ to EPA after the data is collected and the results of the laboratory analysis of the data are provided to DEQ.
- C. By August 5, 2002, DEQ shall develop and provide to the public for comment a state-wide monitoring plan that describes how and when DEQ will address all waters in the state to determine or reevaluate support status.

## VII. Termination of Settlement Agreement, Dismissal of Claims and Releases.

- A. Upon execution of this Settlement Agreement, Plaintiffs and EPA shall stipulate to dismiss without prejudice the remaining allegations of the Complaint in the Litigation, in accordance with the stipulation attached hereto as Attachment 4.
  - B. Upon Final Action By DEQ on the last TMDL called for in the Schedule:
    - (1) DEQ's obligations under this Agreement shall be terminated; and
- (2) Plaintiffs shall be deemed to release, discharge and covenant not to assert (by way of commencement or refiling of any action, the joinder of DEQ in an existing action, or in any other fashion) any and all claims, causes of action, suits or demands of any kind in law or in equity that Plaintiffs may have had, may now have or hereafter may have against DEQ that could have been asserted in the Litigation or in a state civil or administrative action by Plaintiffs based upon the facts existing at the time Plaintiffs enter into this Agreement related to the establishment of the TMDLs for the WQLSs or waterbody/pollutant combinations listed on the 1997 Schedule, Attachments 1 or 2, or any waterbody/pollutant combinations substituted for waterbody/pollutant combinations for WQLSs on the Schedule pursuant to Paragraph IV.A above. Specifically, Plaintiffs agree not to assert (by way of commencement or refiling of any action, the joinder of DEQ in an existing action, or in any other fashion) any claims against DEQ alleging that DEQ has unreasonably delayed or failed to take final action as required by state or federal law on the TMDLs for the WQLSs or waterbody/pollutant combinations listed on the 1997 Schedule, Attachments 1 or 2, or any waterbody/pollutant combinations substituted for waterbody/pollutant combinations for WQLSs on the Schedule pursuant to Paragraph IV.A above. This release of claims does not include any claim substantively challenging the TMDLs for the WQLSs or waterbody/pollutant combinations listed on the 1997 Schedule, Attachments 1

or 2, or any waterbody/pollutant combinations substituted for waterbody/pollutant combinations for WQLSs on the Schedule pursuant to Paragraph IV.A above. This release of claims also does not include any claim challenging DEQ's decision to seek EPA approval for delisting any waterbody/pollutant combinations.

- C. Upon EPA's fulfillment of its obligations under this Settlement Agreement,
  - (1) EPA's obligations under this Agreement shall be terminated; and
- (2) Plaintiffs shall be deemed to release, discharge and covenant not to assert (by way of commencement or refiling of any action, the joinder of EPA in an existing action, or in any other fashion) any and all claims, causes of action, suits or demands of any kind in law or in equity that Plaintiffs may have had, may now have or hereafter may have against the United States and/or EPA that were asserted or could have been asserted in the Litigation by Plaintiffs based upon the facts existing at the time Plaintiffs enter into this Agreement related to the establishment of the TMDLs for the WQLSs or waterbody/pollutant combinations listed on the 1997 Schedule, Attachments 1 or 2, or any waterbody/pollutant combinations substituted for waterbody/pollutant combinations for WQLSs on the Schedule pursuant to Paragraph IV.A above. Specifically, Plaintiffs agree not to assert (by way of commencement or refiling of any action, the joinder of EPA in an existing action, or in any other fashion) any claims against the United States and/or EPA alleging that EPA has unreasonably delayed or failed to take final action on the TMDLs for the WQLSs or waterbody/pollutant combinations listed on the 1997 Schedule, Attachments 1 or 2, or any waterbody/pollutant combinations substituted for waterbody/pollutant combinations for WQLSs on the Schedule pursuant to Paragraph IV.A above. This release of claims does not include any claim substantively challenging EPA decisions establishing or approving the TMDLs for the WQLSs or waterbody/pollutant

combinations listed on the 1997 Schedule, Attachments 1 or 2, or any waterbody/pollutant combinations substituted for waterbody/pollutant combinations for WQLSs on the Schedule pursuant to Paragraph IV.A above. This release of claims also does not include any claim challenging EPA's approval of the delisting of any waterbody/pollutant combinations.

#### VIII. Dispute Resolution.

In the event of a disagreement between the parties concerning the interpretation or performance of any aspect of this Settlement Agreement, the dissatisfied party shall provide the other party with written notice of the dispute and a request for negotiations. The parties shall meet and confer in order to attempt to resolve the dispute within 30 days of the written notice, or such time thereafter as is mutually agreed. If the parties are unable to resolve the dispute, then Plaintiffs' sole remedy is to refile claims from the Litigation. Plaintiffs may not refile claims from the Litigation prior to 60 days from the date of the meeting and conference following the written notice of the dispute, and plaintiffs have specified that they will provide a 60-day notice as set forth in section 505(b) of the CWA, 33 U.S.C. § 1365(b), before filing any such claims. EPA and DEQ do not waive or limit, and expressly reserve, any and all defenses relating to such litigation. DEQ expressly reserves any available defenses to federal court jurisdiction, including any constitutional defense, and DEQ does not consent to jurisdiction in federal court.

#### IX. Force Majeure.

The parties recognize that EPA's performance under this Settlement Agreement is subject to fiscal and procurement laws and regulations of the United States which include, but are not limited to, the Anti-Deficiency Act, 31 U.S.C. § 1341, et seq. Nothing in this agreement shall be construed to commit a federal official to expend funds not appropriated by Congress. Further, the possibility exists that circumstances outside the reasonable control of EPA or DEQ could

delay compliance with the timetables contained in this Settlement Agreement. Such situations include, but are not limited to, sufficient funds not being appropriated as requested, appropriated funds not being available for expenditure, or catastrophic environmental events requiring and immediate and/or time-consuming response by EPA or DEQ. Should a delay occur due to such circumstances, any resulting failure to meet the timetables set forth herein shall not constitute a failure to comply with the deadlines or other terms of this Settlement Agreement, and any deadlines so affected shall be extended one day for each day of the delay. EPA or DEQ will provide Plaintiffs with reasonable notice in the event that EPA or DEQ invokes this term of the Settlement Agreement. Any dispute regarding invocation of this provision shall be resolved in accordance with the dispute resolution provision of Section VIII above.

#### X. SFCDA Decision.

The Parties recognize that the Schedule is premised upon the fact that DEQ does not adopt TMDLs as rules pursuant to the Idaho Administrative Procedure Act. The Parties further recognize that, if DEQ were to adopt TMDLs as rules as discussed in the SFCDA decision, DEQ's ability to meet the deadlines in the Schedule might be affected and DEQ might determine that it is necessary to modify the Schedule to accommodate such rulemaking. If DEQ determines that it is necessary to modify the Schedule to accommodate such rulemaking, DEQ shall notify the Parties of its determination and shall provide the Parties with a proposed revised schedule and the Parties shall attempt to agree on a revised schedule. If the Parties are unable to agree on a revised schedule within 60 days of the date that DEQ provides a proposed revised schedule or within such other time to which the Parties agree, DEQ may modify the Schedule as it deems necessary to accommodate such rulemaking. Any dispute regarding the new schedule shall be resolved in accordance with the dispute resolution provision of Section VIII above. Plaintiffs

expressly reserve their position that EPA should establish TMDLs if DEQ is unable to meet the deadlines in the Schedule.

#### XI. Agency Discretion.

Except as expressly provided herein, nothing in this Settlement Agreement shall be construed to limit or modify the discretion accorded EPA or DEQ by the Clean Water Act, 33 U.S.C. §§ 1251-1387, or by general principles of administrative law. Thus, nothing in this Agreement shall be construed to limit or modify EPA's or DEQ's discretion to alter, amend or revise from time to time any actions that EPA or DEQ may perform pursuant to this Agreement, including to promulgate regulations or to establish superseding TMDLs.

#### XII. <u>Effective Date</u>.

This Settlement Agreement shall become effective upon its execution by the parties.

#### XIII. Effect of Settlement Agreement and Remedy For Non-Compliance.

This Settlement Agreement shall not constitute an admission or evidence of jurisdiction of the federal district court over EPA or DEQ in the Litigation or any fact, wrongdoing, misconduct or liability on the part of the United States or the State, their officers, or any person affiliated with them. The provisions, terms and conditions of this Agreement shall not be admissible in any judicial or administrative proceeding, except at the request of DEQ or EPA in defense of any judicial or administrative claim related to the pace of establishment of TMDLs for the State of Idaho. A determination that DEQ is in compliance with the overall pace of the Schedule on any judicial or administrative claim alleging that EPA or DEQ failed to approve or establish a sufficient number of TMDLs for the State of Idaho shall constitute a complete defense to that claim, requiring dismissal of the claim. If at any time after the execution of this Settlement Agreement Plaintiffs believe that DEQ or EPA is not in compliance with this

Agreement, Plaintiffs' sole remedy is to refile claims from the Litigation. Plaintiffs shall invoke the Dispute Resolution provisions of Section VIII above before any such refiling. The parties agree that contempt of court is not an available remedy under this Settlement Agreement.

### XIV. Notice.

Any notice required or made with respect to this Settlement Agreement shall be in writing and shall be effective upon receipt. Any notice or other documents required pursuant to this Settlement Agreement shall be sent to the following contact persons:

### XV. Representative Authority.

Each undersigned representative of the parties certifies that he or she is fully authorized by the party to enter into this Agreement and to bind such party to comply with the terms and conditions of this Agreement.

### XVI. Mutual Drafting.

It is expressly understood and agreed that this Settlement Agreement was jointly drafted by the parties. Accordingly, the parties hereby agree that any and all rules of construction to the effect that ambiguity is construed against the drafting party shall be inapplicable in any dispute concerning the terms, meaning, or interpretation of this Agreement.

### XVII. Counterparts.

This Settlement Agreement may be executed in any number of counterpart originals, each of which shall be deemed to constitute an original agreement, and all of which shall constitute

one agreement. The execution of one counterpart by any party shall have the same force and effect as if that party had signed all other counterparts.

## XVIII. Compliance With Other Laws.

No provision of this Settlement Agreement shall be interpreted as or constitute a commitment or requirement that EPA obligate or pay funds in contravention of the Anti-Deficiency Act, 31 U.S.C. § 1341, or that EPA or DEQ take actions in contravention of the Administrative Procedure Act, 5 U.S.C. §§ 551-559, 701-706, the Clean Water Act, or any other law or regulation, either substantive or procedural.

### XIX. Applicable Law.

This Settlement Agreement shall be governed and construed under the laws of the United States.

#### XX. Third-Party Beneficiaries.

Nothing in this Settlement Agreement shall be construed to make any person or entity not executing this Agreement a third-party beneficiary to this Agreement.

#### XXI. Consent to Form and Substance.

The parties consent to the form and substance of this Agreement.

#### **XXII.** Integration Clause.

This agreement constitutes the final, complete and exclusive agreement and understanding between Plaintiffs, EPA and DEQ with respect to the matters addressed in this Agreement. There are no representations, agreements or understandings relating to this settlement other than those expressly contained in this Agreement.

#### XXIII. Changes in Law.

If, subsequent to the execution of this Agreement, any change in the law goes into effect that alters or relieves EPA or DEQ of the obligations concerning matters addressed in this Agreement, then the Agreement shall be amended to conform to such changes. The parties specifically recognize that, if and when it takes effect, the Revisions Rule might affect DEQ's performance and obligations under this Agreement. Any dispute regarding invocation or the applicability of this provision shall be resolved in accordance with the dispute resolution provision of Section VIII above.

### XXIV. Modifications.

The Parties may agree, in a written document signed by all of the Parties, to modify this Agreement.

#### XXV. General Reservation of Rights.

Except as set forth in this Agreement, the parties reserve and do not waive any and all other legal rights and remedies.

WHEREFORE, after having reviewed the terms and conditions of this Agreement,

# RESPONSE TO COMMENTS ON THE PROPOSED TMDL SETTLEMENT AGREEMENT

#### **Settlement Agreement Attachments Unclear**

#### Comment (IFA):

The attachments to the Settlement Agreement were unclear and appeared inconsistent with the language in the Settlement Agreement.

#### Response:

DEQ agrees that the attachments should be clarified and has made the following changes:

- 1) The "New Due Date" heading was removed from Attachment 1 and replaced by the heading "Due Date."
- 2) The heading "303(d) Changes" on Attachment 2 was modified to make it clear this column is intended to identify the pollutants proposed to be removed from the 303(d) list.
- 3) The title of Attachment 3 was changed to reflect the language at pages 12 and 13 of the Settlement Agreement.
- 4) DEQ has explained and defined abbreviations and acronyms used in the attachments.
- 5) The formatting and labeling of the attachments was made consistent.

#### **Revisions Rule**

## Comment (IFA):

Regarding the references to the "revisions rule" in the first full paragraph on page 4 of the Settlement Agreement. The "revisions rule" should not affect the settlement and the parties should not try to agree to a rule that may go into affect or may change.

## Response:

The referenced paragraph was not intended to suggest that the parties were agreeing to the application of the "revisions rule" or that the "revisions rule" was a part of the settlement. Instead, the paragraph simply provides that the parties recognize that, should the "revisions rule" take effect in the future, it may affect the performance and obligations under the Settlement Agreement. This, in turn, may require the parties to review potential modifications of the agreement.

## Changes to the 1997 Schedule

## Comment (IFA & IWUA):

In reference to the first sentence on page 8 and paragraph XX on page 20 of the Settlement Agreement, while the parties may agree that the 1997 schedule is null and void, the Settlement Agreement cannot affect the rights of parties to the litigation which led to the 1997 schedule. The Settlement Agreement should include the following language: "Nothing in the Agreement shall in any way affect or limit the rights of parties in Case No. 93-943." (IFA)

The 1997 TMDL schedule cannot be amended or replaced without the express written consent of the parties to the <u>Idaho Sportsman Coalition v. Browner</u> litigation. (IWUA)

#### Response:

The schedule dated April 3, 1997 arose out of the <u>Idaho Sportsman Coalition v. Browner</u> litigation. The 1997 schedule, however, was not a part of any court order or enforceable agreement between the parties. As a result, Plaintiffs in the current litigation and any other parties or intervenors to the prior litigation do not have a right to enforce or prevent changes to the 1997 schedule. Moreover, the 1997 schedule, like any TMDL schedule, was intended to be a living document and subject to change based on changes in circumstances, including changes in § 303(d) lists, as long as appropriate notice was provided. In addition, the schedule in the Settlement Agreement clearly is a "reasonable schedule" as discussed by the court in the <u>Idaho Sportsman's Coalition v. Browner</u> litigation. Finally, DEQ has provided notice and an opportunity to comment for parties and intervenors to the prior litigation, and any other members of the public regarding the new schedule.

# Notice to Nonparties; Access to Reports and Other Documents Under the Settlement Agreement; Involvement in Dispute Resolution

#### Comment (IFA):

The Settlement Agreement should require EPA and DEQ provide individual notice of changes in the schedule to all parties to the 1997 litigation and provide such parties copies of all progress reports, TMDL s and EPA approval letters.

## Response:

The Settlement Agreement requires DEQ provide notice to the public of any changes in the schedule. The progress reports, TMDLs, and EPA approval letters are all available to members of the public under state and federal public records laws. The Settlement Agreement does not alter these requirements or in any way preclude public access to these documents. Members of the public, therefore, will be adequately notified of changes to the schedule and will have reasonable access to the referenced documents.

## Comment (IFBF):

Progress reports and other documents should be provided to IFBF and other stakeholders and stakeholders should be allowed to be involved in dispute resolution over performance of any aspect of the Settlement Agreement.

#### Response:

The progress reports and other documents provided under the Settlement Agreement are available to members of the public pursuant to state and federal public records laws. The Settlement Agreement does not alter these requirements or in any way preclude public access to these documents. The Settlement Agreement also in no way restricts the ability of stakeholders to become involved in TMDLs or listing decisions. State law requires the involvement of the public through the WAGs and BAGs and federal law also requires public participation in TMDL development and listing decisions. The Settlement Agreement does not diminish this public involvement, but instead helps to ensure the public is notified and has an opportunity to comment by requiring a set and uniform public notice and comment procedure when listing decisions are made. In addition, the dispute resolution provisions of the Settlement Agreement relate only to disagreements regarding the Settlement Agreement, which establishes a schedule for developing TMDLs. DEQ does not anticipate that the procedure for implementation of a wasteload allocation will be subject to dispute resolution under the Settlement Agreement.

#### Comment (IWUA):

Progress reports and other documentation should be automatically provided to IWUA.

## Response:

The progress reports and other documents referenced in the Settlement Agreement are all available to the public pursuant to state and federal public records laws. The settlement Agreement does not alter these requirements or in any way preclude public access to these documents. Therefore, DEQ believes that IWUA and other members of the public will have reasonable access to such information.

## Schedule for Development of TMDLs for Waterbody/Pollutants Combinations on Attachment 2

#### Comment (IFA):

The Settlement Agreement is not clear with respect to how the schedule to develop TMDLs for water body/pollutant combinations DEQ has proposed to delist, but which subsequently are not delisted, fit within the overall schedule set forth in Attachment 1.

#### Response:

DEQ agrees that the Settlement Agreement may be unclear as to the schedule for the development of TMDLs for water body/pollutant combinations set forth on Attachment 2 that are proposed to be delisted, but are subsequently not delisted. DEQ has changed the Schedule to reference all the proposed delistings on Attachment 2. The Schedule lists all of the Attachment 2 water bodies and indicates that these water bodies will be addressed under the procedures and time frames described in paragraphs IV and VI of the Settlement Agreement. This change clarifies that all the proposed delistings on Attachment 2 that are not delisted will remain on the schedule.

## Implementation Strategies and Implementation of TMDLs

#### Comment (IFA):

Paragraph C on page 8 should be amended to indicate that EPA agrees that implementation strategies are not required to be submitted and will not be approved or disapproved by EPA and to clarify that the implementation strategies are informational and not to be approved or disapproved.

## Response:

DEQ has changed paragraph C as follows: "<u>EPA</u>, DEQ and the Plaintiffs understand, however, that EPA will approve or disapprove only the TMDLs defined by 40 C.F.R. § 130.2(i) and that, pursuant to regulations in effect at the time this Agreement is executed, EPA will not approve or disapprove the attached Summary of Implementation Strategies. Further, <u>EPA</u>, DEQ and the Plaintiffs understand that the presence or absence of a

Summary of Implementation Strategies will not be a factor in EPA's decision to approve or disapprove the TMDL. DEQ and the Plaintiffs agree that the Summary of Implementation Strategies shall include..."

DEQ feels that the paragraph is otherwise clear that the implementation strategies are not to be approved or disapproved and, therefore, declines the suggestion to make further changes.

## Comment (IFBF):

Regarding the requirement in the Settlement Agreement that a Summary of Implementation Strategies be attached to all TMDLs submitted to EPA. IFBF commented that it was concerned regarding the identification of entities or individuals involved or responsible for implementing TMDLs, how DEQ will ensure individual nonpoint sources are doing their part in implementing the TMDLs, and the enforcement mechanism regarding voluntary BMPs.

## Response:

The Settlement Agreement does not affect DEQ or other designated state agency authorities, programs or procedures regarding implementation of TMDLs and enforcement mechanisms. TMDLs implemented through voluntary BMPs will continue to be implemented in this manner.

## Comment (IWUA):

The Summary of Implementation Strategies should not be submitted to EPA because such implementation strategies are not required to be submitted to EPA under the Clean Water Act.

## Response:

DEQ agrees that the Summary of Implementation Strategies are not required to be submitted to EPA or approved/disapproved by EPA. DEQ believes the Settlement Agreement is clear on this point.

While not required by federal law, Idaho Code § 39-3611 does require DEQ to identify pollutant control strategies. The Settlement Agreement, therefore, does not require DEQ to undertake work DEQ does not already do pursuant to state law. In addition, DEQ believes a Summary of Implementation Strategies may be helpful in framing, at the TMDL development stage, the implementation issues DEQ will need to address when it subsequently develops an implementation plan. Therefore, DEQ does not propose to delete the provisions relating to the Summary of Implementation Strategies.

## Statewide Monitoring Plan and Funding for Monitoring and Implementation

## Comment (IFA):

Asked whether under the statewide monitoring plan developed under paragraph VI.D, DEQ intended to visit stream segments or some other water body.

## Response:

The monitoring plan will likely address waters on a different scale than stream segments. In addition, DEQ has changed the word "visit" to "address" in this paragraph because, while DEQ's monitoring and analysis will address all waters, it is impractical for DEQ to visit all waters in the state within any reasonable timeframe.

## Comment (IFBF):

Commented regarding the funding and nature of monitoring related to TMDLs.

#### Response:

The state is required under state and federal law to determine the beneficial uses and support status of water bodies in the state. As described in paragraph VI.D of the Settlement Agreement, DEQ is developing a state-wide monitoring plan to meet this requirement. This monitoring will largely be funded by the state.

## Comment (multiple parties and individuals):

Many commentors support the TMDL settlement, but are concerned that sufficient funding be made available for monitoring and development and implementation of TMDLs.

#### Response:

DEQ agrees that funding for the TMDL program is critical to its success. DEQ will continue to fund the TMDL program to the fullest extent reasonable given the overall DEQ and state budgets.

#### Water Body Assessment Guidance (WBAG)

#### Comment (IFBF):

Asked whether the new WBAG will be used to meet load allocations.

#### Response:

The WBAG is used to determine whether water bodies in the state meet state Water Quality Standards and support designated and existing uses. The WBAG will not be used to determine load allocations or as a means of implementing TMDLs.

#### **Time Frame for Meeting Water Quality Standards**

## Comment (IFBF):

Asked what happens if the time frame for meeting Water Quality Standards is not realistic or is not met.

## Response:

As a threshold matter, DEQ notes that the Settlement Agreement establishes a schedule for developing TMDLs, not meeting Water Quality Standards. DEQ, however, hopes and expects that the TMDLs will lead to achievement of Water Quality Standards in a reasonable time. DEQ recognizes that implementation strategies for TMDLs must be flexible plans that change if, for example, monitoring during implementation indicates that time frames or goals are unrealistic or if the standards upon which a TMDL is based change. The Settlement Agreement does not affect this approach. Instead, the Settlement Agreement is consistent with this approach as it indicates on page 9 that DEQ recognizes its strategies for TMDLs may need to be modified depending on the results of monitoring during implementation.

## Flow Alteration and Temperature Standards

#### Comment (IWUA):

TMDLs should not be required for water bodies listed for flow alteration and such water bodies should be removed from the 303 (d) list and the schedule.

## Response:

DEQ agrees that TMDLs are not required for water bodies impaired solely as a result of "flow alteration." DEQ intends to address this issue in the 2002 303(d) list and by subsequent changes to the schedule. Any such changes will be reflected in the annual progress reports required to be prepared under paragraph V of the Settlement Agreement.

## Comment (IWUA):

The schedule does not indicate those water bodies for which temperature TMDLs will be developed and that such information must be made available in order to analyze the Settlement Agreement. IWUA also commented that the Settlement Agreement does not address the method by which DEQ intends to address the difficulties of meeting the state temperature standards.

#### Response:

DEQ believes that it has provided information that reflects the scheduling of temperature TMDLs.

DEQ agrees that there are many difficult temperature issues that must be addressed. DEQ continues to participate in national, regional and state efforts to resolve these issues. DEQ, however, must continue to meet its obligations under the Clean Water Act and state laws to develop TMDLs. DEQ has attempted to phase in the development of TMDLs so that DEQ can take advantage of progress and changes in water quality standards and the method in which such TMDLs are developed.

#### **Release Language and Dispute Resolution Language**

#### Comment (IWUA):

The release language in the Settlement Agreement is not strong enough.

#### Response:

While commenting that the release language was inappropriate, no changes to the language were suggested to meet this concern. Moreover, DEQ believes the current release language is adequate.

## Comment (IWUA):

The dispute resolution language made it too easy to reopen the litigation. It is suggested that the dispute resolution language provides that DEQ will be subject to litigation under the agreement.

## Response:

While commenting that the dispute resolution language was inappropriate, suggested changes to the language to address this concern was not provided. Moreover, DEQ believes the dispute resolution language is adequate. DEQ disagrees that the Settlement Agreement in any way implies a recognition that DEQ will subject itself to litigation. To the contrary, paragraph VIII is clear that DEQ does not consent to jurisdiction in federal court and that DEQ reserves all defenses to any potential litigation.

## Comment (Willow Creek WAG):

The Willow Creek WAG suggested the TMDL for the Willow Creek drainage be delayed until after 2002.

## Response:

The Willow Creek TMDL (HUC #1704205) is on the schedule to be completed in 2003.

## Comment (Nez Perce and Coeur d'Alene tribes):

The tribes expressed concerns regarding the timing and authority to develop TMDLs for waters on tribal reservations. The tribes also suggested that the due date for certain TMDLs be changed.

## Response:

Language was added to the Settlement Agreement that provides nothing in the agreement shall be deemed to recognize, imply, or confer state authority or jurisdiction under the Clean Water Act over any Indian Country, as defined at 18 U.S.C. § 1511. DEQ also changed the due dates for certain TMDLs in response to comments.
