On April 29, 2003 EPA and the cooperating agencies will hold a public hearing at the Delta Junction Community Center, 2288 Deborah Street from 4:00 p.m. to 9:00 p.m.; and on April 30, 2003 at the Chena River Convention Center at 109 Clay Street in Fairbanks from 4:00 p.m. to 9:00 p.m.

The Environmental Protection Agency (EPA) is pleased to announce that a Draft Environmental Impact Statement (DEIS) for Teck-Pogo, Inc.'s proposed Pogo Gold Mine Project, near Delta Junction, will soon be available for a 60-day public review.

EPA is the lead agency for the EIS process because the project needs a National Pollutant Discharge Elimination System (NPDES) permit. Our project team, which includes the State of Alaska and the U.S. Army Corps of Engineers as cooperating agencies, has studied how the proposed project could affect people and the environment. The team has also developed and looked closely at reasonable project alternatives based on input from the public, tribal governments, and other state and federal agencies.

The comment period for the draft EIS will begin on March 14, 2003 and end on May 13, 2003. EPA will respond to all comments on the draft EIS in the final EIS. I encourage you to submit your comments and views during the public comment period so your concerns can be addressed. The EIS process is designed to provide interested citizens, tribes, and government officials an opportunity to comment on the alternatives and our analysis of potential project impacts.

The consulting firm Michael Baker, Jr., Inc. assisted in preparing the Draft EIS. The Draft EIS describes how the proposed project could affect people, animals, and the ecosystem. It also identifies the agencies' overall preferred project alternative, and includes several key draft permits as appendices, including the State of Alaska's draft permit for the access road. The agencies want to give all DEIS reviewers a complete picture of the possible impacts of the proposed project and alternatives. We also want to show how key parts of the project, including access and water quality, would be regulated. Therefore, we invite DEIS reviewers to comment on the proposed NPDES permits as well as other draft permits included in the DEIS during the 60-day comment period.

Over the past two years, EPA and the cooperating agencies have been working with Teck-Pogo, Inc. on its operating plans and permit applications. As a result of discussions with not only federal and state agencies and Tribal Governments, but also input from a wide range of other stakeholders, Teck-Pogo, Inc. has proposed some changes to its operations. Some specific changes are:

- Mine site facilities have been moved to consolidate and generally lessen the overall project footprint and minimize water runoff.
- A new, innovative waste water treatment system has been proposed.

EPA welcomes your comments and looks forward to your continued participation in the EIS process.
