NCR Celebrates Two Child Care Center Openings

Innovation Station Child Development Center, located on the site of the new Patent and Trademark Office campus in Alexandria, Virginia, opened its doors on April 5, 2004. The 17,069 square foot center serves 138 children. The center has a modern and contemporary design with large windows in each room that provide a flood of natural light. The program is managed by Bright Horizons and offers a scientific and technological curriculum emphasizing science, mathematics, and technology.

On May 12, 2004, the United States Census Bureau celebrated the opening of Suitland Federal Child Development Center with an Open House and Dedication Ceremony. The 7.200 square foot facility is a pre-engineered center, complete with a state of the art playground, is designed to accommodate 68 children. The design and construction of the center was completed in 18 months. Children from families working in the U.S. Census Bureau, U.S. Navy, and NOAA share the facility. The center is managed by Angelic Care, Child & Dependent Care Solutions.

Kevin's Corner

Letter from the "Corporate" World

I was recently assigned to a position in the newly created Office of Applied Science (incidentally, Child Care will be located in the same office), as the "Subject Matter Expert" for Workplace.

It's an opportunity to advance, on perhaps a larger scale, the core idea which the GSA Child Care has been pursuing for lo, these many years: *Space matters* - and not just because well-designed and well-appointed facilities are pretty to look at, or make for good press. Those things are nice, and highly desirable. But in a world of tight resources, the expenditures of taxpayer money must have a greater justification.

And here is that justification: Properly designed space is *essential* for creating those bedrocks of quality care: Nurture and trust between child and adult. When these occur, Federal families know it. This allows them to more fully dedicate themselves to the Public's business. Over the years, as GSA's Child Care program has established itself as World-class, we have come to know this hypothesis about the importance of space is true, and have (largely) convinced others that it is. This core belief has become part of our culture at GSA and contributes greatly to the Agency's National recognition in this field.

In the same way, the fledgling Workplace Program is founded upon the belief that properly designed space is an *essential* tool for optimizing worker's talents. We cannot expect topnotch knowledge workers to work at their best with outmoded technology that fights their efforts. Why should we expect excellence from them if they are housed, as is too often the case, in ill-considered facilities that fight them at every turn? If this belief of the Workplace Program sounds like the hypothesis on which quality child care space founded, that's because it is: **Space matters** - It is more than overhead. It is the silent partner of success.

So here is where it gets interesting: As part of my new duties, I recently attended a Conference in Chicago, The CoreNet Global Summit: all real estate executives -the movers and the shakers of the commercial real estate industry. Very adult. Imagine my surprise, when in a session I attended about a hugely successful case study on a very innovative and profitable company headquarters, the presenter identified the provision of on-site child care as the lynchpin to the project's success and its resulting immense profitability! Of course, we in Child Care know that, but it was intensely gratifying, and even startling to hear it in this context and from a source least expected: the money people! It made me realize that these two fields really are integrated and they collaborate toward providing an integrated world-class workplace for a world-class workforce, which is GSA's mission.

As for me and my future:, I will always be around for consultation even as the Office of Applied Science welcomes fresh (and yet-to-be determined) talent. The reason is simple. In my professional life I have had the opportunity to work for clients as "important" and diverse as developers, Federal Judges, and even King Fahd of Saudi Arabia. But nothing can equal the satisfaction of having made the journey of childhood in these turbulent times a little better. Ultimately, that's what appropriate, well-designed and beautiful space does: It *really* does it makes life better - or so I believe.
