SUBJECT: DMERCs and VIPS, Processing NDC Numbers – Clarification to CR 3141

#### I. GENERAL INFORMATION

The purpose of this instruction is to provide Durable Medical Equipment Regional Carriers (DMERCs) and VMS with additional instructions for processing Health Insurance Portability and Accountability Act (HIPAA) compliant claims in the NCPDP format. The information in this instruction supplements the information distributed in CR 3141. This information applies to DMERCs and VIPS.

## A. Background:

With the implementation of HIPAA, DMERCs now receive many NDCs for drugs.

### B. Policy

DMERCs and VMS shall receive a new update of the NDC crosswalk file in April and monthly updates thereafter.

- NDC codes that have been deactivated on the NDC crosswalk, shall be rejected beginning immediately.
- VMS shall load the NDC crosswalk file.
- SADMERC, VMS and DMERCs shall work together to incorporate ICD-9 codes into the NDC crosswalk if appropriate.
