SUBJECT: Railroad Medicare Carrier Collection of Data

This Change Request supersedes CR 2777, B-03-054

I. GENERAL INFORMATION

A. Background:

This Change Request outlines the need for CMS to collect Medicare Claims System (MCS) carrier Provider Enrollment System (PES) database file information and Viable Medicare System (VMS) carrier Provider Enrollment System (PENS) and Provider File information, the submission of required information, the schedule for the effort, and mailing instructions.

As part of managing the Medicare program, CMS/Program Integrity (PI) is responsible for enrolling and maintaining up-to-date enrollment information related to Medicare providers/suppliers. In an effort to streamline the enrollment process and to enhance the collection and maintenance of this information, CMS/PI has recently implemented the Provider Enrollment Chain and Ownership System (PECOS). PECOS allows the regional offices, fiscal intermediaries, carriers, National Supplier Clearinghouse, and other participating organizations to collect and enter enrollment related data into the central system residing at CMS' central office.

With the implementation of PECOS, the Railroad Medicare Carrier (RMC) has asked the carriers for provider enrollment information that is more up to date or that does not exist in the RMC MCS system. These additional requests have created a resource strain for all parties involved. To help meet the processing timeliness for RMC and the Part B-Carriers and to reduce the number of requests coming from RMC, the archived production PES and PENS database from each MCS/VMS carriers will be sent to RMC. This information will be utilized by RMC to locate the information needed for the provider/suppler. It will allow them to process their claims and enable them to generate an initial PECOS record for that carrier

Carriers have been electronically storing the 855 data in either the PES database or their VMS PENS or Provider File. This data needs to be transmitted to RMC for the purpose of assisting the RMC with expediting their claims processing and provider enumeration process. This instruction is to request that the all MCS and VMS Part B carriers electronically download all provider enrollment data from their PES by creating a copy of their existing production PES database for MCS users and Copies of their PENS and VMS PROVFILE for VMS users. It is understood that the carriers are not doing any analysis of the data being sent; it is strictly a data copy/dump. This database dump will be stored on a CD-ROM and/or Tape and sent to the RMC's technical area.
