

## The William B. Abrams Award in **Geriatric Clinical Pharmacology**

#### HISTORY

👝 William B. Abrams Award in Geriatric Clinical Pharmacology was established, with support from the Merck Company Foundation, by Dr. Abrams to honor a young investigator in the field of Geriatric Clinical Pharmacology for making outstanding contributions to the field.

Dr. Abrams, a Past President of ASCPT, had a long and illustrious career in the pharmaceutical industry, mostly at the Merck Research Laboratories. Among his many accomplishments in geriatric clinical pharmacology, he was the founding Co-Editor of the Merck Manual of Geriatrics, was responsible for the creation of the Scientific Section on Geriatric Clinical Pharmacology of ASCPT, and for developing and funding post-doctoral training programs in geriatric clinical pharmacology.

#### **GOAL OF THE AWARD**

Dr. Abrams' objective in establishing this award was to encourage more young scientists to enter the field of geriatric clinical pharmacology by recognizing their accomplishments at the Society's Annual Meeting.

#### **ELIGIBILTY/REQUIREMENTS**

A nominee must be a young investigator in geriatrics who is actively engaged in high-quality teaching and research in geriatric clinical pharmacology. The nominee must not be more than 45 years of age as of March 1 of the year in which the award is presented.

#### PRIZE AND PRESENTATION

The William B. Abrams Award in Geriatric Clinical Pharmacology is presented during the ASCPT Annual Meeting. The recipient will receive a plaque and a \$1,000 honorarium. Travel expenses, hotel expenses and meeting registration are paid for by the Society. This award is funded on behalf of Dr. Abrams through the generosity of The Merck Company Foundation.

## The Henry W. Elliott Distinguished Service Award

#### HISTORY

The Henry W. Elliott Distinguished Service Award was established in March 1978 to honor an ASCPT member who has gone above and beyond the call of duty in service to the organization.

#### **GOAL OF THE AWARD**

The goal of the Henry W. Elliott Award is to acknowledge outstanding efforts on behalf of the organization by an individual member and in doing so, encourage other ASCPT members to contribute their time and talent to the Society.

#### **ELIGIBILITY/REQUIREMENTS**

The recipient should be a member of ASCPT and cannot have held the position of President-Elect or President of the Society within the last five years.

The essential criterion is service to ASCPT. There should be documented evidence of excellent service to the organization. One or two outstanding acts of service or a long record of many acts of service without any single outstanding act may justify the award. The recipient should have a record of continuous service to the Society, including one or many major accomplishments.

Examples of accomplishments worthy of recognition include the establishment of effective programs; important administrative work which converts one or more committees from "just another red tape operation" into an effective instrument for progress in clinical pharmacology; effective advocacy of important solutions to major issues affecting clinical pharmacology; development of important liaisons among appropriate groups replacing

#### HISTORY

The Leon I. Goldberg Young Investigator Award was first given in 1986. The award was established as a means to recognize young members of the Society for the early career accomplishments they achieve and to serve as a platform for young members to present their research and receive recognition for their work.

#### **GOAL OF THE AWARD**

The goal of The Leon I. Golberg Young Investigator Award is to encourage and recognize young scientists active in the field of clinical pharmacology.

#### **ELIGIBILITY/REQUIREMENTS**

The candidate should be a member of the Society and must not be more than 41 years of age by March 1 of the year of presentation of the award. The nominee may have earned their doctoral degree in any scientific field. The nominee should be an accomplished young investigator in the field of clinical pharmacology.

#### PRIZE AND PRESENTATION

The Leon I. Goldberg Young Investigator Award is presented during the ASCPT Annual Meeting. The recipient will present a lecture focusing on their research in clinical pharmacology. The recipient will receive a 1,000.00 honorarium, a plaque and a complimentary meeting registration. Travel expenses will be paid for by the Society.

## The Oscar B. Hunter Memorial Award in Therapeutics

#### HISTORY

The Oscar B. Hunter Memorial Award in Therapeutics was established to honor Dr. Oscar Benwood Hunter Sr. who joined the American Therapeutic Society in 1928 and for many years was the guiding light of the American Therapeutic Society engendering a spirit of force and energy in the furtherance of the Society's objectives in the field of experimental therapeutics. He was elected to the office of Secretary in 1937, which office he held until his death in 1951, except for the year 1938 when he was elected President.

#### **GOAL OF THE AWARD**

The Oscar B. Hunter Award is the Society's premier award. The goal of the Oscar B. Hunter Memorial Award in Therapeutics is to honor an individual scientist for outstanding contributions to clinical pharmacology and therapeutics over ones professional life. The award recognizes a meritorious career in drug research, excellence in direct patient care or very important contributions to patient care, and a distinguished teaching career.

#### **ELIGIBILITY/REQUIREMENTS**

To qualify for the Oscar B. Hunter Memorial Award in Therapeutics one must be able to provide evidence of an exemplary career in drug research, significant contributions to excellence in patient care, and a distinguished teaching career.

## The Gary Neil Prize for Innovation in Drug Development

#### HISTORY

The Gary Neil Prize for Innovation in Drug Development was established in 2002 to honor the memory of Gary Neil, Ph.D. Dr. Neil, a former head of worldwide Research and Development at Wyeth-Ayerst, was a leader in the field of drug development. Dr. Neil was instrumental in creating a highly effective drug development and strategic decision-making structure at Alza through his roles as CEO and President of Therapeutic Discovery Corporation and Crescendo Pharmaceuticals Corporation. Dr. Neil played a significant role as a member of the boards of directors of Pharsight Corporation, Geron Corporation, Calydon and several other biotech companies.

#### **GOAL OF THE AWARD**

The goal of the Gary Neil Prize for Innovation in Drug Development is to stimulate the application of innovative science to clinical drug development, by recognizing outstanding individuals or teams who have been leaders in this area.

#### **ELIGIBILITY/REQUIREMENTS**

Individuals as well as teams from the pharmaceutical or biotechnology industry are eligible for the Gary Neil Prize for Innovation in Drug Development. The only requirement is that the candidate be a leader in the application of significant, innovative science to clinical drug development. The relevant work must have occurred while working in the pharmaceutical or biotechnology industry, however, candidates need not currently be employed in industry.

#### PRIZE AND PRESENTATION

The Gary Neil Prize for Innovation in Drug Development is presented at the ASCPT Annual Meeting in the year that the award recipient is determined. The recipient of the Gary Neil Prize will receive a plaque and a \$2,500.00 honorarium. Travel expenses, hotel expenses and meeting registration are paid for by the Society.

## The Rawls-Palmer Progress in Medicine Lecture Award

#### HISTORY

The Rawls-Palmer Progress in Medicine Lecture Award was established in 1978 by Dr. W.B. Rawls in the hopes that it would be a real educational process and would serve to bring the efforts of modern research to the care of the patient and to help bridge the gap between the results of research and its application to the care of the patient.

Dr. Rawls was a member of the Society for many years, and he and his wife had many fond memories of friendships which originated at the meetings. Dr. and Mrs. Rawls' parents were children immediately after the Civil War and educational opportunities were poor, but they insisted that all their children have a full education. The Rawls-Palmer Progress in Medicine Lecture Award was also established to honor Dr. and Mrs. Rawls' parents, Mr. and Mrs. Gray M. Rawls of Williamson, Georgia and Mr. and Mrs. Nathaniel J. Palmer of Milton, North Carolina, for their foresight and sacrifices.

#### **GOAL OF THE AWARD**

The goal of The Rawls-Palmer Progress in Medicine Lecture and Award is to recognize a clinical pharmacologist for significant contributions to drug investigation that brings the efforts of modern drug research to the care of patients.

#### **ELIGIBILITY/REQUIREMENTS**

The candidate must be an investigator who is actively engaged in highquality clinical pharmacologic research. The candidate must be capable of delivering an engaging, lucid lecture with wide audience appeal on recent developments in clinical pharmacology and therapeutics.

#### PRIZE AND PRESENTATION

The Rawls-Palmer Progress in Medicine Lecture Award is presented during the ASCPT Annual Meeting. The recipient will present a lecture focusing on recent developments in clinical pharmacology. In addition, the recipient will receive a \$1,000.00 honorarium, a plaque and a complimentary Annual Meeting registration. Travel expenses will be reimbursed.
