

## REPORT ON WIC FOOD COSTS – FEBRUARY 2001

### FOOD PRICE INDICES:

#### 1. The Thrifty Food Plan Index:

Thrifty Food Plan (TFP) Costs are published monthly by the USDA Center for Nutrition Policy and Promotion. The cost index for the Food Stamp Program (FSP) reference household, a family of four, including two children ages 6-8 and 9-11, is used by FNS to calculate the inflation factor used to allocate WIC State food grants.

The cost of the Thrifty Food Plan for the FSP reference household was \$444.20 in January 2001, an increase of \$10.80 or 2.49 percent from January 2000, and an increase of \$2.70 or 0.61 percent from December 2000.

#### 2. Consumer Price Index:

The Bureau of Labor Statistics (BLS) produces monthly consumer price data for food and other consumer goods. The Consumer Price Index for all Urban Consumers (CPI-U) for Food at Home is a measure of the average change in prices over time for a fixed market basket of retail foods purchased by consumers for day-to-day living. Food prices are collected every month in 85 urban areas across the country from about 19,000 retail establishments. The average food prices reflect variation in brand, quality, and size among geographical areas. The CPI measures price change from a base period, 1982-84, which equals 100.0. Thus, a CPI of 134.6 means that the price has increased 34.6 percent since the 1982-84 base period.

The January 2001 Consumer Price Index (CPI) for "Food at Home" was 171.3, which is an increase of 0.6 percent above the December 2000 level, and 3.0 percent higher than one year before in January 2000.

#### 3. Average Retail Prices:

BLS also reports U.S. average prices for selected foods, including the following components of the WIC food package:

Please note that the prior year prices and changes reported **do not represent average annual** prices or changes, but those from the same month one year prior. Prior year changes do not necessarily indicate a prolonged or permanent price trend. Also, the price series for carrots, fresh, short-trimmed, topped, per pound, was discontinued by the Bureau of Labor Statistics after October 2000.
