## DECISION OF THE BOARD OF CONTRACT APPEALS

August 23, 1999

## OPINION BY ADMINISTRATIVE JUDGE ANNE W. WESTBROOK

On May 26, 1999, the Board received these appeals from Thompson Museum Consulting (Appellant), of St. Paul, Minnesota. Both appeals involve Forest Service Contract No. 53-56A2-7-1081 for technical planning and design of exhibits and other interpretative modules for the Northern Great Lakes Visitors' Center. AGBCA No. 1999-166-1 is an appeal from a decision of the Contracting Officer (CO) dated January 19, 1999, denying Appellant's claims for an equitable adjustment for alleged extra work. The amount at issue was \$21,716.47. AGBCA No. 1999-167-1 is an appeal from the CO's March 15, 1999 decision claiming damages in the amount of \$25,460 for Appellant's alleged failures to deliver certain items of work and for defects in the work delivered.

The Board has jurisdiction of the appeals under the Contract Disputes Act (CDA), 41 U.S.C. §§ 601-613, as amended.

August 23, 1999

Upon docketing, the Board directed Appellant and the Government to file complaints in AGBCA Nos. 1999-166-1 and 1999-167-1, respectively. The Board also held a telephonic conference with the parties on July 6, 1999. Thereafter, the Board received correspondence from both parties indicating that the appeals had been settled. By letter dated July 29, 1999, counsel for Appellant informed the Board that in light of the settlement of all outstanding issues relating to Contract No. 53-56A2-7-1081, Appellant was withdrawing both of the appeals.

<u><b>DECISION</b></u> In accordance with the request of the Appellant, the appeals are dismissed with prejudice.
