- 9 State has a tobacco-free environment if it has adopted policies prohibiting all of the following: cigarette smoking, smokeless tobacco use, and cigar or pipe smoking by students, faculty and staff, and visitors in school buildings and outside on school grounds, in school buses or other vehicles used to transport students, and at off-campus school-sponsored events.
