SUBJECT: Council on Regulatory Environmental Modeling

In February 2000, EPA established the Council for Regulatory Environmental Modeling (CREM) to ensure adequacy and consistency in model development, evaluation, and application. With the endorsement of the SPC, the CREM has been working on a number of activities, including model evaluation guidance and a models inventory. To complete this current work and to advance the CREM's ongoing mission to enhance the development and use of environmental models, I am taking two steps.

First, I have asked ORD's Office of Science Policy (OSP) to assume responsibility for staffing the CREM. Acting OSP Director, Debbie Dietrich, has asked Gerardo Pascual in OSP's Cross-Program Staff to serve as CREM team leader in a permanent capacity; other CREM staff may be added in the future. As in the past, we are interested in exploring detail opportunities for staff to work with Pasky on CREM activities. Gary Foley, Director of the National Exposure Research Laboratory, will continue to chair the CREM.

Second, to reaffirm cross-agency CREM leadership and involvement, I request that each SPC member identify a senior manager at the division director level or higher to serve on the CREM. If your office already has a CREM member, please submit that person's name to confirm his or her status as a current member. In addition, you may submit the names of staff you would like to serve on CREM action teams, which are listed in the attachment to this memorandum. Names should be sent to Gerardo Pascual by Friday, June 14. Your office's nominee should plan to attend a June 20 meeting, chaired by Gary Foley, to discuss how to continue the progress made to date by the CREM.

Thank you for your efforts to advance the work and mission of the CREM. Model development and use are key to the Agency's mission, and therefore require our close attention and commitment.
