SUBJECT: Correction of Some Fiscal Year (FY) 2001 Hospice Wage Indices

The Medicare program is required to announce the annual update to the Hospice Wage Index as required by §1814(i) of the Social Security Act. The annual updates are published in the *Federal Register* and effective on October 1 of every Federal FY. The most recent update to the Hospice Wage Index for FY 2001 was published in the *Federal Register* on October 6, 2000. (See *Federal Register*/Vol.65, No. 195/October 6, 2000.)

After the publication of the October 6, 2000, Hospice Wage Index Notice, we identified nineteen (19) inaccuracies in the wage index tables found in the *Federal Register* (Tables A and B). Upon identifying the inaccurate wage index values, we immediately took steps to ensure that the correct values were incorporated in our hospice payment software (PRICER). Therefore, hospice payments have been made with the correct Hospice Wage Index values since October 1, 2000.

We intend to publish the corrected wage index values in the *Federal Register* as soon as practicable. However, we believe that hospice providers should be alerted to the correct wage index values to assist them in reconciling their Medicare hospice payments. The table below provides the inaccurate wage index values published in the *Federal Register*, as well as the correct wage index values found in the hospice PRICER.

Inform your hospice providers of these corrections by posting this information on your website immediately upon receipt of this Program Memorandum (PM) and follow the website notification by posting this information in your next hardcopy bulletin addressed to hospice providers.
