If the services of a law firm in the Philippines are desired, it is suggested that a definite agreement on the matter of fees be resolved before the services are actually engaged. This is important for the client as well as for the attorney and can prevent possible misunderstanding.

If this list is published, it must be accompanied by the following statement:

These names have been furnished by the American Embassy Manila, Philippines.

American consular officers at any foreign post will furnish such names directly to any American firm or individual requesting them.

SERVICE OF PROCESS

American consular officers are prohibited by regulations from serving legal process emanating from any court, whether in the United States or abroad, and are prohibited from appointing others to do so, except in certain cases in the United States Federal courts involving service of process on United States citizens abroad (28USC 1783 and 1784),

Service of process in the Philippines may be accomplished by various methods (depending on the circumstances of the case), such as by registered mail at last known address, by publications, and personal service which may also be made by other officers of the court, including attorneys. Most American law firms have found it helpful, and in many cases necessary, to engage the service of Philippine attorneys to advise and assist them in effecting service of process in the Philippines.
