

PREFACE

The purpose of the Tampa Bay Environmental Atlas is to compile existing biological and water resource data for the Tampa Bay ecosystem and map these data at a scale of 1:24,000. The atlas was compiled in conjunction with the 1982, 1972, and 1952 wetland land-use mapping of the Tampa Bay area, which is also at a scale of 1:24,000. The Tampa Bay Environmental Atlas consists of composited information overlain on 18 biological and 20 water resource base maps to produce a total of 38 maps, and an accompanying map narrative. Federal, State and local decision-makers will be able to use this atlas and its accompanying map narrative for coastal planning and management of the wetland areas within the Tampa Bay ecosystem study area.

This project was conducted under Contract FWS 14-16-0009-83-002. Funding was provided by the U.S. Fish and Wildlife Service.

1. INTRODUCTION

1.1 GENERAL

The <u>Tampa Bay</u> <u>Environmental Atlas</u> is a comprehensive large-scale atlas of the biological and water resources of the Tampa Bay area. The study area is the greater Tampa Bay coastal region within the following 21 U.S. Geological Survey 1:24,000-scale quadrangle maps (Figure 1):


The atlas is being produced in conjunction with the 1982, 1972, and 1952 wetland land-use mapping of the Tampa Bay area, which is also being mapped at a scale of 1:24,000. The Tampa Bay Environmental Atlas consists of composited information overlain on 18 biological and 20 water resource base maps to produce 38 maps and this accompanying map narrative report. Map numbers A19, A20, A21, and B19 were not printed due to lack of data on the resources of this area. The data used in the production of this atlas meet all cartographic standards and specifications outlined by the U.S. Fish and Wildlife Service. Previously or newly acquired map data and collateral information have been compiled to produce this atlas.


The topics included within this map narrative are biological resources and water resources.

Federal, State, and local decisionmakers will be able to use this atlas for coastal planning and management of the wetland areas within the Tampa Bay ecosystem study area.

Included within the Tampa Bay Environmental Atlas are Tampa Bay (200.4 mi²), Hillsborough Bay (40.4 mi²), Old Tampa Bay (78.3 mi²), Boca Ciega Bay (26.9 mi²), St. Joseph Sound (53.2 mi²), and the northern portion of Sarasota Bay (55.6 mi²). The average depth of these waters is 11.4 ft. (mhw) (McNulty et al. 1972; Lewis and Whitman 1984).

1.2 BIOLOGICAL RESOURCES

The Tampa Bay ecosystem is part of the Outer Coastal Plain Ecological Province according to R.G. Bailey (1978). The Outer Coastal Plain Ecological Province is an area of gentle slopes with numerous rivers and creeks. Swamps, marshes, and lakes are abundant in the region and support a wide variety of animal life. The Hillsborough, Alafia, Little Manatee, and Manatee Rivers all empty into Tampa Bay, which is a drowned river valley.

Biological map topics are approved shellfish harvest areas, oyster beds, clams, scallops, finfish, shore birds, wading birds, manatee habitat, seagrass beds, and artificial reefs.

1.3 WATER RESOURCES

The topics on the water resource maps include salinity (mapped as specific conductivity), point source discharges, dredge spoil disposal areas, tide stations, water quality, bathymetry, the intertidal zone, sediments (mapped by grain size), tidal currents, and the freshwater-saltwater interface.

2. BIOLOGICAL RESOURCES

2.1 APPROVED SHELLFISH HARVEST AREAS

Approved shellfish harvest areas depicted in the atlas are defined by strict water quality standards and do not show actual extent of shellfish Continual monitoring of fecal coliform bacteria levels is aggregations. conducted by the Florida Department of Natural Resources (FDNR), Bureau of the Department's Shellfish Regulation and Development through Marine Environmental Assessment Section. Shellfish harvest areas are classified as either approved, conditionally approved, prohibited, or unclassified. Approved areas consistently fulfill water quality criteria (a total coliform bacteria of less than 70 colonies per 100-ml sample). Conditionally approved areas also meet water quality standards, but are subject to more frequent localized changes from flooding and urban runoff which reduce water quality. Prohibited areas, which consistently do not fulfill such requirements, are officially prohibited for the harvesting of shellfish. Unclassified areas are not subjected to continual water quality monitoring and are officially unapproved for shellfish harvesting. The classification of all coastal and estuarine waters is subject to change due to water quality standards. Current shellfish harvest status of any particular area can be obtained from county health departments and the local office of the FDNR, Shellfish Environmental Assessment Section, Punta Gorda, Florida, (813) 639-3443.

Shellfish is a broad term applied to many invertebrates. The water quality constraints imposed by shellfish harvest areas are directed at those species of shellfish which filter water to feed, specifically clams and oysters. These filter feeders, eaten in their entirety, have the potential to concentrate pathogens and toxins (Palik and Lewis 1984).




Figure 2. Approved shellfish harvest areas in Tampa Bay (Florida Department of Natural Resources 1984).

The generalized location of shellfish harvest areas is shown in Figure 2. Total commercial landings by shellfish species for Pinellas, Hillsborugh, and Manatee Counties for 1982 are itemized in Appendix C.

2.2 OYSTER BEDS

The American oyster (<u>Crassostrea virginica</u>) spawns during the late spring and summer, generally from April through October. Larvae are pelagic for 2-3 weeks, then settle and become permanently attached to pilings, red mangrove roots, seawalls, or hard substrate in the form of oyster reefs. They then grow rapidly, provided water flow, temperature, and salinity are favorable. Good water flow not only aids in dispersal of the larvae, but also assures transport of nutrients and removal of wastes. Oysters can tolerate a wide salinity range (10-30 ppt). Temperatures of 25° to 26 °C and salinities of

25 ppt promote optimal growth. Oysters in Florida attain marketable size in about 3 years. Oysters are filter feeders, sorting food by size during ingestion. Phytoplankton, bacteria, and detritus are important foods (McNulty et al. 1972).

In the Tampa Bay study area, this species grows on nearly any suitable substrate such as seawalls and ridge-shaped reefs. The large, naturally occurring aggregations of oysters are depicted on the atlas maps as public oyster beds (Oys-1).

In selected areas, portions of submerged lands within estuaries have been leased by private interests from the State of Florida to grow oysters. These areas appear on the atlas maps as private oyster beds (Oys-2). Certain areas acquired for oyster growing were subsequently closed to shellfish harvesting by the FDNR due to water quality below approved criteria.

Because they are filter feeders, oysters can concentrate micro-organisms and heavy metals as much as several thousandfold; this poses a potential health hazard since oysters are often found in shallow estuaries which may be contaminated with effluent containing pathogenic bacteria and viruses. For this reason, oyster harvesting is regulated according to strict water quality standards. Because estuarine water quality is subject to rapid change, oyster areas must be monitored frequently and may be only conditionally approved. State law prohibits taking oysters between June 1 and August 31. The minimum allowable size for taking oysters is 3 inches as determined by State law. Oysters are not a commercially important shellfish in the Tampa Bay study area; only 132 lb brought in \$167 in 1982 (Snell 1984).

2.3 CLAMS

Three species of clams occur in significant abundance in the Tampa Bay study area: the northern quahog (<u>Mercenaria mercenaria</u>), the southern quahog (<u>Mercenaria campechiensis</u>), and the sunray venus clam (<u>Macrocallista nimposa</u>). All are found in estuaries and coastal waters from the mean high tide level to depths of 50 ft and in salinities of 20-35 ppt. Generalized areas of known clam concentrations as determined by Sims and Stokes 1967, Godcharles and Jaap 1973, Tracy 1983, and Sprague 1984 are shown as closed polygons on the individual atlas maps (please see Section 6.1.3).

Clams prefer sandy bottoms in areas of low turbidity (clear water). Too much silt in the water can smother the animals. In bays, clams tend to occur in seagrasses and algal assemblages. The northern quahog did not historically occur on the west coast of Florida, but recent introductions appear to have established successful populations in Tampa Bay. Quahogs spawn between April and August, and sunray venus clams from July through December. Planktonic larvae remain in the water column for about 2 weeks before settling and burrowing into the sediments. Juveniles are subject to predation by the blue crab (<u>Callinectes sapidus</u>). Southern quahogs grow to commercial size rapidly, reaching minimum size in 1 to 1.5 years, while northern quahogs require 2 to 3 years, and sunray venus clams 5 to 6 years. The life expectancy of quahogs can be more than 15 years. Clams are suspension feeders, filtering detritus and micro-organisms from the water column. Thus, they may accumulate toxins and pathogens associated with red tides or polluted water. Areas of Tampa Bay support clam fisheries on a sporadic basis. State law regulates clam harvesting according to water quality standards; also, certain kinds of harvesting equipment (dredges) are prohibited because they cause excessive damage to sensitive areas such as seagrass meadows (Godcharles and Jaap 1973).

Clams are harvested in the Tampa Bay area in waters mostly less than 5 ft by the use of handheld clam rakes which cause little increase in water turbidity (McNulty et al. 1972; Palik and Lewis 1984). Clams are not a commercially important shellfish with only 70 lb bringing in \$158 in 1982 (Snell 1984). However, they represent a commercially valuable recreational fishery.

2.4 FINFISH SPAWNING, NURSERY, AND HARVEST AREAS

The sheltered embayments of the estuaries in and around Tampa Bay provide vital habitat for adult and nursery stocks of the commercial and recreational finfish found in the Tampa Bay study area.

Finfish spawning, nursery, and harvest areas are keyed to a species data matrix in the supplemental legend of each biological resource map.

2.4.1 Estuarine-Dependent Fishes

The following finfish descriptions were taken from Palik and Lewis 1984. Landings by fish species can be found in Appendix B.

2.4.1.1 <u>Red drum (Sciaenops ocellatus</u>). Red drum inhabit estuarine and nearshore Gulf of Mexico waters. Spawning occurs in nearshore coastal areas beginning in September and continuing through February. Larvae are transported to estuarine nursery areas by currents, where they remain during the summer, developing into juveniles which leave the estuary with the onset of cold weather. As the fish mature, they apparently prefer to spend more time in the shallow nearshore gulf. Red drum are primarily bottom feeders with a preference for crabs and shrimp. They exhibit secondary midwater and surface feeding. There is a 12-inch minimum size limit on red drum.

2.4.1.2 <u>Spotted seatrout (Cynoscion nebulosus</u>). The spotted seatrout is very closely tied to the estuary. Spawning occurs within the estuary and possibly in those waters immediately adjacent to the mouth of the estuary. South Florida stocks apparently spawn year round with a major peak in the spring and a minor peak in the fall. Essentially nonmigratory, seatrout exhibit a random residential range within the estuary. Tagging studies have shown that most fish move less than 30 mi. Seagrass meadows are the primary habitat for the spotted seatrout.

Each estuary appears to have a unique breeding stock, each stock having slightly different morphological traits. Habitat preference appears to be seagrass beds. Spotted seatrout feed on fish, shrimp, and other crustaceans and become more piscivorous as they mature. A 12-inch minimum size limit is imposed throughout the study area.

2.4.1.3 Snook (Centropomus undecimalis). Snook are essentially tropical sensitive to cold-induced mortality. possibly Spawning, fish and lunar-induced, occurs at and near tidal passes from late May through July. Eggs and larvae are transported to estuarine and brackish nursery areas by Juveniles live in the upper reaches of the estuary, primarily in currents. brackish streams, ditches, and tidal freshwater creeks. Snook are essentially nonmigratory, but do exhibit a residential range within the estuary and a net movement to the passes during the spawning season. Snook feed on fish and crustaceans. A closed season on snook exists between June 1 and July 31 and between January 1 and February 28. A possession limit of two fish and a minimum size limit of 18 inches have also been imposed. This judicious action has been imposed in an effort to promote recovery of a declining population.

2.4.1.4 <u>Sheepshead (Archosargus probatocephalus</u>). The sheepshead is a popular sport fish caught along piers, bridges and seawalls of the Tampa Bay area. It is considered an advanced member of the family Sparidae, which is a group of deep bodied perciform fishes that primarily have a tropical distribution. Spawning takes place from March to May along the sandy beaches in the early evening. Juveniles migrate to seagrass areas after hatching. Adult sheepshead generally inhabit areas of rocks, piling, and seawalls in the bays and usually school before spawning just offshore of the major bays. The chief foods for adults are hard mollusks and crustaceans (Mook 1971).

2.4.1.5 <u>Southern flounder (Paralichthys lethostigma</u>). Spawning occurs offshore in fall and winter when adults migrate from estuarine and coastal nearshore waters. The buoyant eggs usually hatch within 2 days, and larvae move to inshore and estuarine nursery areas. During this time, the symmetric larvae undergo a metamorphosis in which the skull contorts and the right eye moves around to the left of the body. Juveniles typically inhabit shallow estuarine grass beds where they feed largely on marine worms, crustaceans, and fish. Adults are capable of protective coloration changes to blend with the surrounding bottom and feed almost exclusively on fish and crustaceans. The State has imposed an 11-inch minimum size limit on flounders.

2.4.1.6 <u>Florida pompano (Trachinotus carolinus</u>). Although the exact spawning location is unknown, pompano are considered to spawn offshore, evidenced by the appearance of very early larval forms in offshore gulf waters. The peak of an extended spawning season is from April through June. Rapidly growing juveniles prefer open beach areas where they forage for crustaceans and mollusks. Florida supplies nearly 90% of the U.S. population of pompano, which commands the highest price per pound of any fish in the Southern United States. Florida law prohibits the harvest of pompano less than 9.5 inches long.

2.4.1.7 <u>Striped mullet (Mugil cephalus</u>). Spawning occurs between October and January in offshore waters. Floating eggs typically hatch within 2 days, and the developing planktonic larvae move into estuarine nursery areas where they remain until sexual maturity, approximately 2 to 3 years. Larvae and small juveniles feed on zooplankton, while juveniles and adults are herbivorous, feeding on diatoms, algae, and benthic detritus. With the

exception of the seaward spawning migration in the fall, mullet remain in and are directly dependent on the estuary.

2.4.1.8 <u>Gulf menhaden (Brevoortia patronus</u>). The gulf menhaden is abundant in the northern Gulf of Mexico, and commercial harvesting efforts are concentrated in that region. Spawning probably takes place in coastal inshore areas. Planktonic larvae are selective carnivores and migrate inshore and enter the estuarine nursery areas as juveniles. Juveniles develop a specialized gill raker-alimentary tract complex with which they feed by nonselective omnivorous filtering. Movement into and established residence in the estuary are an integral part of the menhaden life cycle.

2.4.1.9 <u>Black drum (Pogonias cromis</u>). Black drum, although not commercially important, are a popular fish among sports fishermen in Tampa Bay. Black drum use Tampa Bay as a nursery in the summer and fall.

2.4.2 Reef Fishes

Groupers and snappers are important to both the recreational and commercial fisheries of the region. Generally, they spawn offshore over the Continental Shelf. Pelagic larvae are transported great distances by oceanic currents. Upon their arrival at inshore, coastal, and estuarine nursery areas, juveniles seek cover and forage for fishes and crustaceans. Typically, as these fish develop, they move offshore. Although inhabitants of other areas, these fish generally seek out structures with some vertical relief, such as wrecks, artificial and coral reefs, rocky areas, holes, and ledges. Most groupers are protogynous hermaphrodites, beginning life as females and transforming into males at around age 5 to 7 years. The State of Florida imposes a 12-inch minimum size on groupers.

2.4.2.1 <u>Red grouper (Epinephelus morio</u>). Commonly offshore of Tampa Bay, the red grouper spawns in the spring over the Continental Shelf. Juveniles develop in coastal areas and tend to move offshore with age. This is an economically important species in the Tampa Bay study area.

2.4.2.2 <u>Jewfish (Epinephelus itajara)</u>. The jewfish is the largest of the groupers and can attain lengths in excess of 8 ft and weigh over 700 lb. Spawning happens in offshore waters during July and August. Juveniles and young adults inhabit coastal and estuarine seagrass beds and mangroves. Although occasionally occurring inshore, marine jewfish tend to frequent offshore habitats.

2.4.2.3 <u>Gag grouper (Mycteroperca microlepis</u>). The gag and the red are the major groupers contributing to the commercial and recreational fishery. The gag is the most frequently caught inshore grouper on the peninsular gulf coast. Spawning is between January and March in the offshore waters of the Continental Shelf. Juveniles inhabit nearshore and estuarine nursery areas. Though found offshore, adult gag groupers also reside in nearshore habitats.

2.4.2.4 <u>Scamp (Mycteroperca phenax</u>). More common offshore, the adult scamp is not relatively abundant in coastal waters. Scamp spawn offshore

during March and April. Adults are more common over hard, broken bottoms such as rock and coral.

2.4.2.5 <u>Red snapper (Lutjanus campechanus)</u>. Although the specific spawning location is not known, red snapper probably spawn in offshore waters of the Continental Shelf from late June until October. Larvae are transported or move to coastal and estuarine waters. Juveniles prefer inshore areas of mud or sand bottoms and exercise an offshore movement as a function of size. Primarily found offshore, adult red snapper are not harvested in coastal and nearshore waters, but are an economically important species in the region.

2.4.2.6 <u>Mangrove snapper (Lutjanus griseus</u>). Although occurring in offshore habitats, the mangrove snapper is the most common inshore snapper in the Tampa Bay study area. Adults are commonly found around structures, grassbeds, and mangroves in the estuary. However, spawning takes place offshore from April through October. Larvae are transported inshore, and juveniles are common in estuarine seagrass beds and mangrove-fringed shorelines. This species is also referred to as the gray snapper.

2.4.3 Coastal Pelagic Fishes

The mackerels are fast-swimming, oceanic fishes that make extensive seasonal migrations.

2.4.3.1 King mackerel (Scomberomorus cavalla). The king mackerel is one most economically finfish, important both commercially and of the recreationally, in Florida. Spawning occurs in waters over the Outer Continental Shelf and in adjacent offshore currents between May and September. Little is known of juvenile forms; most inshore collections have been incidental in shrimp trawls. Adults undertake mass migrations. Evidently there are several populations of kingfish in Florida, and there is some intermixing. The gulf stock is apparently composed mostly of fish which winter between Cape Canaveral and Key West. These fish move into the gulf in the spring, move north, and spend the summer in the northern gulf as far west as Texas. A return migration to southeast Florida is demonstrated during the fall and winter. Another population of king mackerel, which is present off the southeast coast of Florida in the spring, apparently moves down the Atlantic coast to spawn. Adults feed on small schooling jacks, menhaden and other schooling herring-like fish, shrimp, and squid.

2.4.3.2 <u>Spanish mackerel (Scomberomorus maculatus</u>). The Spanish mackerel also supports a large recreational and commercial fishery in Florida. Whereas king mackerel are not commonly associated with nearshore areas, the Spanish mackerel frequently enters saline embayments during migration. Spanish mackerel spawn over the Inner Continental Shelf from May through September. Juvenile movements are poorly known, although they are captured inshore in shrimp trawls. Separate stocks are presumed for each coast of Florida. Fish wintering in Florida Bay migrate into the northeastern gulf in the spring and return by the following winter. Spanish mackerel feed heavily on menhaden and commonly eat anchovies, small jacks, squid, and shrimp. There is a 12-inch minimum size limit imposed by the State of Florida.

2.5 COLONIAL BIRD NESTING SITES

Habitat diversity, mild winter climate, and geographic location allow Tampa Bay to support one of the richest assemblages of avifauna in the continental United States. The vast expanses of coastal mudflats, saline marsh, and the mangrove-sheltered embayments, as well as the marshes, wooded swamps, and cypress stands of the interior provide the forage areas and nesting substrate essential to the survival of vast populations of seabirds, shore birds, wading birds, and waterfowl which predominate in the region. Nesting colonies are depicted on the atlas by numbered symbols. Species composition of each colony is listed in Appendix D. Information pertaining to the following species was provided by the National Audubon Society, Florida Audubon Society, and <u>Rare and Endangered Biota of Florida</u>, Volume 2, <u>Birds</u> (Pritchard 1978).

2.5.1 Shore birds

Shorebirds include gulls, terns, sandpipers, plovers, stilts, skimmers, and oystercatchers. Resident nesting species use coastal mudflats, saline and brackish marshes, sheltered embayments, and estuarine and coastal open water as forage areas. Nesting usually occurs on undisturbed beaches, islands, and sand spits where vegetation is sparse of absent. Tampa Bay is host to a wide variety of migrant and wintering shore birds including plovers, sandpipers, turnstones, yellowlegs, godwits, and avocets. Gulls and terns capture small fish by hovering and diving.

2.5.1.1 <u>American oystercatcher (Hematopus palliatus</u>). Resident populations are estimated at between 100 and 200 pairs. This local population is augmented by winter migrants from mid-Atlantic States each year. Noncolonial nesting occurs on islands in tidal bays on unvegetated sand or shell well above the high water mark. Two or three eggs are usually laid. Oyster beds and mudflats are the primary forage areas where oystercatchers secure their diet of mollusks and crustaceans. Tampa Bay appears to be an area of concentration for this species. The American oystercatcher is listed as a species of special concern by the Florida Game and Fresh Water Fish Commission (FGFWFC).

2.5.1.2 <u>Snowy plover (Charadrius alexandrius tenuirostris</u>). The Cuban snowy plover is listed as an endangered species by the FGFWFC, and is currently "under review" by the U.S. Fish and Wildlife Service (USFWS). Conservative estimates place the gulf coast population at 100 pairs. Nesting habitat requirements are isolated, expansive, dry, sandy beaches where breeding takes place from April to June. Eggs, usually three, are laid in a shallow depression which is sometimes lined with shell fragments. Snowy plovers forage in search of insects, worms, mollusks, and crustaceans on dry and tidally influenced sand flats. No other bird species in Florida is so dependent on sandy beaches for nesting and foraging habitat. In general, site-specific nesting colony data are sparse for this species due to either the small numbers of individuals which constitute a colony or the transitory nature of the colony location.

2.5.1.3 <u>Wilson's plover (Charadrius wilsonia</u>). The Wilson's plover breeds sporadically from the Tampa Bay area southward through the Keys.

Nesting habitat diversity ranges from interior marshes to dredged spoil islands.

2.5.1.4 <u>Laughing gull (Larus articilla</u>). The laughing gull is the most common breeding gull in the study area. Nests are on both natural and dredged material islands where low vegetation covers sandy soil. Typically one to three eggs are laid in late April and early May, and young birds fledge by late August. The largest laughing gull nesting colony in Florida, composed of about 20,000 individuals, was on a dredged material island in Boca Ciega Bay (Tampa Bay) until it was recently destroyed for a condominium development. The largest current colony is on dredged material disposal islands in Hillsborough Bay (Paul 1984).

2.5.1.5 Least tern (Sterna albifrons). This easily disturbed species requires sandy, unvegetated nesting substrate such as sand spits, islands, dunes, and gravel-covered rooftops. Two eggs are usually laid in shallow scraps in the sand. Nesting begins in late April. The least tern is listed as a threatened species by the FGFWFC. It has recently been found breeding on new dredged material islands in Hillsborough Bay.

2.5.1.6 <u>Royal tern (Sterna maxima</u>). This uncommon tern nests periodically in small numbers in the study area and occasionally within colonies of laughing gulls.

2.5.1.7 <u>Caspian tern (Sterna caspia</u>). This uncommon tern nests on sparsely vegetated islets. The first nesting pair was found in 1961 on a dredge spoil island in Boca Ciega Bay. In 1978, 30 nesting pairs were located in Hillsborough Bay.

2.5.1.8 <u>Gull-billed tern (Gelochelidon nilotica</u>). This relatively rare tern nests in low numbers with colonies of laughing gulls and black skimmers in the Tampa Bay area.

2.5.1.9 <u>Black skimmer (Rynchops nigra</u>). Black skimmers nest from May through August on bare or sparsely vegetated beaches, dunes, spits, or dredged spoil islands.

2.5.2 Wading Birds

Vast expanses of coastal and interior wetland habitat support a great number of colonial nesting wading birds including herons, egrets, and ibises. The following wading bird descriptions were taken from Palik and Lewis (1984).

2.5.2.1 <u>Great blue heron (Ardea herodius)</u>. The great blue heron begins nesting in early January in small numbers with other colonial waders, or in small specific colonies. Major forage areas consist of interior marshes, shallow areas of sheltered saline embayments, and inland bodies of water. Major prey are fish and crustaceans, although the diet may be augmented by small reptiles and mammals. The great blue heron is a common breeding resident in the entire study area.

2.5.2.2 Little blue heron (Florida caerulea). The little blue heron inhabits fresh or brackish marshes. The nesting season begins in February and lasts through August or September. The average clutch size consists of three eggs. Little blue herons prefer freshwater and brackish habitats in which to forage for fish, crustaceans, insects, and small reptiles and amphibians. This species is listed by the state as a species of special concern.

2.5.2.3 <u>Tricolored heron (Hydranassa tricolor</u>). The tricolored heron is common in estuarine habitats where it forages for small fish and crustaceans. Typically the breeding season extends from March to July during which time three or four eggs are laid in mixed or single species colonies. The tricolored heron is listed as a species of special concern by the FGFWFC.

2.5.2.4 <u>Green heron (Butorides striatus</u>). This common species is typically a solitary nester but will sometimes nest in small numbers on the edge of other wading bird colonies.

2.5.2.5 <u>Black-crowned night heron (Nycticorax nycticorax</u>). Feeding occurs in all shallow water habitats, but breeding concentrations appear to be associated with estuarine habitats where nesting is usually in mangroves or Brazilian pepper trees (<u>Schinus terebinthifolius</u>). The species breeds from March to July, and clutch size ranges from two to five eggs. A diet composed largely of fish may be supplemented by mollusks, crustaceans, and small reptiles, amphibians, and mammals. This is the most nocturnal foraging heron, often preying on nestlings of ibis and other herons.

2.5.2.6 Yellow-crowned night heron (Nyctanassa violacea). More diurnal in nature than the black-crowned night heron, the yellow-crowned night heron forages on coastal mudflats for fiddler crabs and other crustaceans which constitute a major portion of the diet. Typically forming small colonies with other yellow-crowned night herons, this bird only occasionally nests with other waders.

2.5.2.7 <u>Cattle egret (Bubulcus ibis</u>). Since its first appearance in 1952, the cattle egret, an Old World species, has become the most abundant bird in mixed-species heronries in Florida. Although it occupies coastal colonies, it rarely forages in marine and estuarine areas.

2.5.2.8 <u>Great egret (Casmerodius albus</u>). The great egret uses a variety of forage habitats, from open pasture and interior impoundments to coastlines and saline marshes. The diet consists of fish, reptiles, amphibians, birds, small mammals, and various invertebrates. The great egret exhibits a preference for more isolated heronries, where two to six eggs are laid per clutch from March through July.

2.5.2.9 <u>Snowy egret (Egretta thula)</u>. Snowy egrets typically nest in mixed-species colonies. Although widely distributed in coastal as well as interior wetlands, larger breeding colonies appear near estuarine habitats. Eggs may be laid as early as December, although most nesting is between March and August. The snowy egret is an active predator, often running through shallow water or along the shoreline in pursuit of small fish. The diet is

also supported by insects and crustaceans. The snowy egret is listed as a species of special concern by the FGFWFC.

2.5.2.10 <u>Reddish egret (Dichromanassa rufescens</u>). Primarily a coastal species, the reddish egret nests on mangrove islands and feeds by actively pursuing fish in the surrounding shallows. Nesting is initiated in April in Tampa Bay. Individual pairs may nest alone, or in small groups associated with mixed-species colonies. Clutch size ranges between two and five eggs. The reddish egret is listed as a species of special concern by the FGFWFC, and is currently "under review" with the USFWS.

2.3.2.11 White ibis (Eudocimus albus). This is an abundant species which flies and feeds in tight flocks. The diet consists largely of crayfish and other crustaceans, but the white ibis also eats insects, mollusks, and small fish which are secured from shallow water areas. The white ibis inhabits both freshwater and estuarine wetlands where it nests on islands, marshes, or in mangroves.

2.5.2.12 <u>Glossy ibis (Plegadis falcinellus</u>). This species inhabits fresh, brackish, and saltwater wetlands, nesting colonially with other wading bird species. Major foraging areas are grasslands, prairies, and high marsh areas which are exposed to seasonal inundation by rainfall. Preferred food items include crayfish and other crustaceans, and insects. Typically three or four eggs are laid in the spring with breeding continuing through the summer.

2.5.2.13 <u>Wood stork (Mycteria americana</u>). The wood stork inhabits freshwater and brackish marshes, where it forms large rookeries, nesting primarily in cypress swamps and protected mangrove embayments. Breeding occurs from November through January with clutch sizes ranging from two to four eggs. Primary feeding areas are pools and depressions in marshes where small fish concentrate. Feeding is accomplished by tacto-location probing. This species is listed as endangered by both the FGFWFC and the USFWS.

2.5.2.14 <u>Anhinga (Anhinga anhinga)</u>. Although the anhinga does nest in some coastal wading bird colonies and is mapped with this group of species, it is chiefly a resident of interior and brackish wetlands. Fish constitute the bulk of the diet and are pursued and captured underwater.

2.5.2.15 <u>Double-crested cormorant (Phalacrocorax auritus</u>). The doublecrested cormorant usually lays three or four eggs with most nesting in April through June; however, nesting has been reported throughout the year. Cormorants dive after and pursue prey underwater, returning to the surface to swallow the food item, usually fish. Double-crested cormorants nest often with colonial wading birds, and for this reason nesting sites are mapped under the heading of wading bird colonies in this atlas.

2.5.3 Eastern brown pelican (Pelecanus occidentalis carolinensis)

The eastern brown pelican is listed by FGFWFC as a species of special concern. Aerial surveys estimate the Florida breeding population to be around 8,000 pairs, of which approximately 50% are in the study area. Nesting occurs in mangroves (<u>Rhizophora mangle</u>, <u>Avicennia germinans</u>), usually on small coastal

islands, from early spring through summer. Two to three eggs are usually laid, and food availability determines fledgling success. The diet consists exclusively of fish, which are secured by plunge diving. Menhaden, mullet, sardines, and pinfish are the major prey. The high incidence of first year mortality (approximately 70%) from starvation may be due to the inefficiency of the young to secure prey.

2.5.4 Other Migrant Bird Species

Other migrant species wintering throughout the study area include common loons (<u>Gavia immer</u>), white pelicans (<u>Pelecanus erythrorhynchos</u>), lesser scaups (<u>Arythya affinis</u>), ruddy duck (<u>Oxyura jamaicensis</u>), red-breasted mergansers (<u>Mergus serrator</u>), and roseate spoonbills (<u>Ajaia ajaja</u>). Migrant bird populations reach their peak between November and January.

2.6 MANATEE HABITAT

The location of all State manatee sanctuaries are shown on the individual biological resource maps and are administered by the Florida Marine Patrol, which is a branch of the Florida Department of Natural Resources. Detailed information on these sanctuaries can be found in the <u>Boater's Guide to</u> <u>Manatees</u>, the <u>Gentle Giants</u> (Florida Marine Patrol 1980). The manatee is considered an endangered species by both the USFWS and the FGFWFC.

2.7 SEAGRASS BEDS

Seagrass meadows have received much attention and are acknowledged to provide sediment stabilization, habitat diversity, nursery habitat for finfish and shellfish, and direct and indirect (detrital) food sources for many marine species. (Phillips 1960, 1978; Taylor and Saloman 1969; Zieman 1982; Lewis et al. 1982).

As a direct food source, seagrasses are consumed by sea urchins, a few fish species, the green turtle and the manatee (Zieman 1982). As habitat, seagrass meadows are particularly important as nursery grounds for juveniles of pink shrimp, several species of grunts and snappers, snook, spotted seatrout, red drum, and sheepshead. The adult form of some of these species may be more commonly associated with other habitats (such as the association of snook with mangroves), but the seagrass nursery habitat is probably vital in providing for adults to be available to commercial and recreational fisheries.

Lewis et al. (1984) reported the occurrence of five species of seagrasses in Tampa Bay:

- 1. Thalassia testudinum (turtlegrass)
- 2. Halodule wrightii (shoalgrass)
- 3. Syringodium filiforme (manateegrass)
- 4. Ruppia maritima (widgeongrass)
- 5. Halophila engelmannii

engermannin

Lewis et al. (1984) estimates that there are 14,202 acres of seagrass in Tampa Bay.

Seagrass beds are portrayed by a habitat screen on the individual biological resource maps. They were delineated from seagrass maps from Lewis (1980) and from 1982 color photography, at a 1:24,000 scale.

2.8 MACROALGAE

Several hundred macroalgae species are found within the Tampa Bay study region (Humm 1973). Macroalgae are frequently the most conspicuous flora in shallow water and proliferate below depths tolerated by seagrasses.

The Tampa Bay study area is the boundary area between tropical and temperate species of brown algae (McNulty et al. 1972). Fifty-one percent of the macroalgae found in the study area are red algae (Rhodophyta), 18% are brown algae (Phaeophyta), and 31% are green algae (Chlorophyta) (Humm 1973).

Unfortunately, the faunal assemblages associated with algal communities in the study area and their ecological roles as habitat and food sources are almost entirely unknown (Palik and Lewis 1984).

During macroalgae blooms, the algae compete with seagrasses for light. These blooms are caused by eutrophication in Tampa Bay.

Macroalgae beds are not mapped on the atlas.

2.9 ARTIFICIAL REEFS

The artificial reefs program of the State of Florida is administered by the Bureau of Marine Science and Technology under Section 370.013 of the Florida Statutes. Approximately \$110,000 in grants were awarded in 1979 and 1980, which were the first 2 years of the newly adopted program (Florida Department of Natural Resources 1981). The principal types of fish inhabiting artificial reefs in the study area's coastal waters are grouper, snapper, Spanish mackerel, king mackerel, and amberjack. A list of artificial reefs keyed by number on the atlas overlays is shown in Table 1.

Florida's coastal waters contain more artificial reefs than any other state (Seaman 1982). Scientific development and deployment of artificial reefs have been slow, with little research and little funding. Without considerable volunteer effort to secure materials and free labor, many of the present artificial reefs in the Tampa Bay study area would not exist. The largest group of organizations which have put together an artificial reef program is in Pinellas County. The cities of Clearwater, Madeira Beach, St. Petersburg, St. Petersburg Beach, and Treasure Island and the Pinellas County Board of Commissioners have built 20 reefs, 10 of which are presently maintained by Pinellas County Mosquito Control. Its annual budget supports a small crew, barge rental, operating expenses, and equipment (Seaman 1982).

Virtually all artificial reefs in Florida are composed of either ships, automobiles, tires, or concrete. New prefabricated artificial reefs are being introduced in Florida (off Fort Lauderdale, Panama City, and Jacksonville) by the Japanese under contract with the National Marine Fisheries Service.

3. WATER RESOURCES

3.1 SALINITY

Salinities have been routinely measured in Tampa Bay since 1954. Since Tampa Bay is a stream-fed estuary, salinities are lowest at the time of maximum stream discharge (normally during the late summer and early fall) and highest at the time of minimum stream discharge (early winter). Historical salinities have ranged from 0.9 to 30.3 parts per thousand (ppt) in Old Tampa Bay (23.5 ppt mean), from 7.4 to 31.9 ppt in Hillsborough Bay (21.8 ppt mean), from 14.0 to 36.8 ppt in Tampa Bay (28.4 ppt mean), from 22.7 to 37.3 ppt in Boca Ciega Bay (32.6 ppt mean), from 1.0 to 33.7 ppt in the lower Manatee River (24.5 ppt mean), and 33.9 to 36.4 ppt in Sarasota Bay (35.4 ppt mean). These salinities are based on observations from 1954 to 1965 by Carl Saloman (McNulty et al. 1972).

Specific conductivity has been measured in Tampa Bay since 1972 by the Hillsborough County Environmental Protection Commission (HCEPC). Salinity is still measured, but the continuity of its data record is not as good as the conductivity data. Specific conductivity or "electrical conductance" is a measure of the ability of water to conduct an electrical current. It is defined as the reciprocal of the resistance in ohms measured between opposite faces of a centimeter cube of an aqueous solution and is expressed in micromhos per centimeter (μ mhos/cm) (Slack and Kaufman 1973).

The relationship of salinity to specific conductivity is well defined, and salinity can be estimated accurately from conductivity data alone. The 1981 mean salinity for all 81 HCEPC water quality stations was 20.5 ppt; average conductivity was 32,200 μ mhos/cm. To convert conductivity (μ mhos/cm) to salinity (ppt), divide the conductivity data by 1, 570.

3.2 POINT SOURCE DISCHARGES

3.2.1 Industrial Point Source Discharges

The Florida Department of Environmental Regulation (FDER) in Tallahassee keeps an updated computer data base on all industrial point source discharges in the study area. Individual point source discharges are numbered and plotted on the individual atlas maps. A list describing each individual point source is found in Table 2 (Florida Department of Environmental Regulation 1983a).

3.2.2 Municipal Point Sources Discharges

The FDER keeps an updated computer data base on all industrial point source discharges in the study area. Individual municipal point source discharges are numbered and plotted on the individual atlas maps. A list describing each individual point source is found in Table 3 (Florida Department of Environmental Regulation 1983b).

3.2.3 Municipal Point Source Discharges Processing Hazardous Wastes

All municipal point source discharges located in the study area process hazardous waste according to Moon (personal communication 1984). Hazardous waste includes any toxic substance which could poison the environment if not disposed of properly. Examples include petroleum products, pesticides, herbicides, nuclear wastes, and most chemicals.

3.3 DREDGE SPOIL DISPOSAL AREAS

The U.S. Army Corps of Engineers is the Federal agency responsible for all dredge and fill activity in the State. A permit must be obtained from the Corps before any dredge and fill activity will be allowed. The FDER is the State agency responsible for permitting all dredge spoil disposal sites in the State. They maintain location maps and site data on all dredge spoil disposal sites in the study area. Individual public or private dredge spoil sites have been plotted on the atlas overlays and represent all dredge spoil disposal sites permitted by the FDER.

3.4 TIDE STATIONS

3.4.1 Tide Station Locations

The National Ocean Service (NOS) has collected tidal data at 104 station locations in the study area. The Clearwater and St. Petersburg Municpal Pier tide stations are the only permanent NOS tide stations in the study area. Individual sites at which data have been collected are numbered and plotted on the individual atlas overlays. Table 4 describes the station and its data record (NOS 1983). 3.5 WATER QUALITY

The Hillsborough County Environmental Protection Commission has collected monthly water quality data from approximately 81 sampling stations in the study area since 1972. The data from these stations were used exclusively to generate the 5-year seasonally averaged water quality parameter means presented in this atlas.

Most of the problems with water quality in Tampa Bay are found in Hillsborough Bay where high fecal coliform, phosphorus, chlorophyll, turbidity, and low dissolved oxygen persist. The north prong of the Alafia River exhibits the worst water quality problem found in the Alafia River Basin. High nutrient levels, as well as low dissolved oxygen, can probably be attributed to phosphate mining activities in this watershed. The Little Manatee River has high phosphorus and fecal coliform levels which probably result from agricultural and rangeland activities in the region. The Manatee River exhibits no major water guality problems.

3.5.1 Methodology

For the purposes of this study, the following five water quality parameters have been seasonally averaged for the most recent 5-year data period available (September 1978 through August 1983):

- 1. Total chlorophyll (µg/l)
- 2. Specific conductivity (middepth; µmhos/cm)
- 3. Turbidity (NTU)
- 4. Temperature (middepth; °C)
- 5. Total nitrogen (mg/1)

The locations of all the sampling stations averaged by season for this study are numbered and plotted on the individual atlas maps. The seasonal averages by water quality parameter for each station are listed in Appendix A and are listed by station on the supplemental map legend. For purposes of this study, winter is composed of the months of December, January, and February; spring is March, April, and May; summer is June, July, and August and fall is September, October, and November.

3.5.2 Total Chlorophyll

Total chlorophyll is an indirect measure of the quantity of planktonic algae present in a body of water and as such is an indicator of eutrophication. It is measured in micro-grams per liter (μ g/l). Total chlorophyll varies seasonally and is highest in the summer and lowest in the winter.




Figure 3. Isopleth map of mean annual total chlorophyll (μ g/l) for Tampa Bay; 5-year mean, Sept. 1978 - Aug. 1983 (data from Hillsborough County Environmental Protection Commission 1983).

A complete isopleth map of the 5-year annual mean for total chlorophyll is shown in Figure 3. Most of the water quality problems associated with high total chlorophyll levels are in Hillsborough Bay. A lesser area of high chlorophyll levels is in extreme western Old Tampa Bay. High chlorophyll levels are associated with algal blooms. One type of algae, the dinoflagellate species, <u>Ptychodiscus brevis</u>, is a toxic red-tide organism which has plagued Tampa Bay for many years. In 1971, Tampa Bay experienced a major red-tide

outbreak which was responsible for the death of millions of fish throughout the bay. Another lesser outbreak was in 1974. Minor outbreaks were in 1978, 1979, 1980, 1981, and 1983 with no significant fish kills (Wilkins 1983).

3.5.3 Specific Conductivity

Specific conductivity is a measure of the ability of water to conduct an electrical current. It is measured in micromhos per centimeter (μ mhos/cm) at standard temperature (25 °C) and pressure (760 mm/Hg) (Slack and Kaufman 1973). Specific conductivity is easily determined by a field meter, and it is a good indicator of salinity.




Figure 4. Mean monthly stream discharge (1952-1966) for four major rivers discharging into Tampa Bay; 5-year mean, Sept. 1978 - Aug. 1983 (data from McNulty et al. 1972).

Specific conductivity levels vary seasonally and correlate well with stream discharge. During the late summer and early fall, when stream discharge normally is at its annual maximum, conductivity levels normally reach their annual minimum as freshwater discharge mixes with bay waters. During the early winter when stream discharge usually reaches its annual minimum conductivity levels are normally at their highest annual levels (see Figure 4). Minimum bay conductivity levels are always at times of maximum streamflow. Maximum conductivity levels are at the end of sustained low-flow periods. Maximum and minimum conductivity levels are usually about two months apart.




Figure 5. Isopleth map of annual specific conductivity (mmhos/cm) for Tampa Bay; 5-year mean, Sept. 1978 - Aug. 1983 (data from Hillsborough County Environmental Protection Commission 1983).

Conductivity levels are lowest in the upper reaches of Tampa Bay nearest the freshwater discharge sources and progressively increase, reaching their greatest levels near the mouth of Tampa Bay (see Figure 5).

Conductivity values on the maps are in mmhos/cm. The values in the supplemental legend should be in µmhos/cm and are mislabeled on the maps. To convert conductivity (mmhos/cm) to salinity (ppt), divide the conductivity data by 1.57.

3.5.4 Turbidity

Turbidity is an expression of the optical quality of a water sample to scatter and absorb light rather than transmit light in straight lines. It is measured in Nephelometric Turbidity Units (NTU's). High turbidity levels are not always associated with poor water quality. Rather, they reflect the material held in suspension in the water column. High-turbidity levels may be associated with algal blooms, dredging activities, or with suspended solids associated with high wind-driven waves in shallow areas of the bay.




Figure 6. Isopleth map of annual turbidity (NTU's) for Tampa Bay; 5-year mean, Sept. 1978 - Aug. 1983 (data from Hillsborough County Environmental Protection Commission 1983).

The highest turbidity levels found in Tampa Bay are located in Hillsborough Bay, extreme western Old Tampa Bay, and at the mouth of the Little Manatee River. These three areas all exhibit moderate to heavy algal blooms primarily during the spring months. In Tampa Bay as a whole, turbidity varies seasonally, reaching a peak in the spring and its lowest point during the winter. A complete isopleth map of mean annual turbidity levels for Tampa Bay for the past 5 years is shown is Figure 6.

3.5.5 Temperature

Water temperature is cyclic in Tampa Bay and is measured in either degrees




Figure 8. Isopleth map of annual middepth water temperature (°C) for lampa Bay; 5-year mean, Sept. 1978 - Aug. 1983 (data from Hillsborough County Environmental Protection Commission 1983).

Fahrenheit (°F) or in degrees Celsius (°C). A 16-year mean monthly plot of water temperature for the NOS tide station at the St. Petersburg Municipal Pier is shown in Figure 7. The maximum observed surface water temperature was 90.1 °F (32.2 °C), and the minimum observed water temperature was 52.3 °F (11.3 °C). Fish kills often result from rapid temperature decreases associated with sudden prolonged occurrences of Arctic air masses during the late fall or early winter. During these periods, the water temperature will often drop below the above-listed minimum in shallow water areas. A massive fish kill in January of 1977 was associated with record low bay water temperatures. An isopleth map of mean annual middepth water temperature for Tampa Bay is shown in Figure 8.

3.5.6 Total Nitrogen

Total nitrogen is the sum of all the nitrogen compounds found in a water sample and is measured in milligrams per liter (mg/l). The highest concentrations of total nitrogen are found in Hillsborough Bay. The principal sources of total nitrogen are urban runoff, agricultural runoff, industrial and domestic waste, and rainfall.




Figure 9. Isopleth map of annual total nitrogen (mg/l) for Tampa Bay; 5-year mean, Sept. 1978 - Aug. 1983 (data from Hillsborough County Environmental Protection Commission 1983).

Maximum nitrogen levels occur in the late summer and early fall and minimum levels in the late fall. An isopleth map of mean annual total nitrogen levels in Tampa Bay is shown in Figure 9.

3.5.7 <u>Hillsborough County Environmental Protection Commission Water Quality</u> Stations


Hillsborough County operates 81 water quality sampling stations with a period of record of greater than 5 years. Sixty-five of these stations are in the study area and are mapped on the atlas maps.


3.6 BATHYMETRY




Figure 10. Example of a bathymetric map of Tampa Bay (1:250,000 scale); 2-m contour interval (NOS 1976).

Tampa Bay is a drowned river valley. An old submerged Pleistocene river delta is located west of Mullet Key. The Hillsborough River became an entrenched stream during this earlier sea-level stand, and portions of this entrenchment are still reflected in the bathymetry south of the interbay Peninsula and north of Egmont (see Figure 10).

Most of the bottom features in Tampa Bay represent surficial sand wave deposits. Major concentrations of hard rock outcroppings are south of the interbay Peninsula where submarine limestone cliffs line an old Pleistocene entrenched stream bed under Gandy Bridge and offshore from Bishop's Harbor and Rattlesnake Key.

Three main submarine physiographic regions are located in the Tampa Bay complex. They are shallow marine grass and sand flats with average depths of approximately 4 ft, slopes adjacent to the flats ranging in depth from 4 to 20 ft, and deep tidal channels greater than 20 ft deep. Twenty percent of the bay complex is less than 6 ft in water depth. Fifty percent of the bay bottom lies between 6 and 18 ft, and 30% is greater then 18 ft deep (Goodell and Gorsline 1961). The average depth of the Tampa Bay complex is 11.4 ft (McNulty et al.

1972). The total surface area at mean high water is 346.0 mi^2 (Lewis and Whitman 1954).

A 2.0-m bathymetric contour interval is used on the individual atlas maps with an initial 1.0-m supplemental contour line used to denote shoals. The bathymetry was compiled by the author and represents an update on the 1976 NOS map for the region.

Boca Ciega Bay lies just north of the Tampa Bay complex and represents a small, shallow lagoon behind the coastal barrier islands. Its average water depth is only 6.6 ft (mhw) (McNulty et al. 1972). Immediately to the north of Boca Ciega Bay lies St. Joseph's Sound, which is another small, shallow lagoon behind the coastal barrier islands. Its average water depth is 4.9 ft (mhw) (McNulty et al. 1972). Sarasota Bay lies just south of the mouth of Tampa Bay. It is a small, shallow lagoon lying behind the coastal barrier islands with an average water depth of 5.5 ft (mhw) (McNulty et al. 1972).

3.7 INTERTIDAL ZONE

The intertidal zone is a region of saltwater marshes and tidal flats that surround Tampa Bay. It is demarcated on the individual atlas overlay maps and was determined from the latest NOS nautical charts for the region.

The intertidal zone is a important buffer zone for marine organisms and biota in Tampa Bay.

3.8 SEDIMENTS

During the early Holocene, Tampa Bay was a drowned river valley with very little sediment accumulation and an average depth of 30 ft. Sediment accumulation since that time has reduced the average depth of Tampa Bay of 11.4 ft (McNulty et al. 1971).

The Tampa Bay complex is composed of a number of interconnected bays. The three principal bays which make up the "Y"-shaped bay complex are Old Tampa Bay to the northwest, Hillsborough Bay to the northeast, and Tampa Bay to the south.

The sediments in the Tampa Bay complex are uniform in character. They are generally composed of reworked terrace quartz and nearshore sand and biogenic carbonate detritus. The mean size of the sediments increases from the upper to the lower reaches of the bay complex. Organic sediments and clays are prominent, primarily in the upper portions of Hillsborough Bay and in other isolated portions of the bay complex (Goodell and Gorsline 1961).

The coastal littoral drift of sand is to the south in Boca Ciega Bay and to the north, south of the mouth of Tampa Bay. North of Tampa Bay, offshore shoaling is occurring to the southwest of the major passes. South of Tampa Bay, shoaling and accretion are taking place to the northwest of the major passes (Goodell and Gorsline 1961). In the sand and grass flats which make up about 15% of the Tampa Bay complex, the sediments are almost entirely quartz sand. The sediments along the slope environments, which make up more than 60% of Tampa Bay, are composed primarily of coarse sand and mollusk shell fragments. The channel sediments are composed almost entirely of very coarse sand and mullusk shell detritus (Goodell and Gorsline 1961).






Figure 11. Generalized sediment map of the Tampa Bay area (adapted from Taylor and Saloman 1969).

A small-scale version of the generalized sediment zones included on the individual atlas maps is shown in Figure 11. The generalized sediment zones portrayed on the individual atlas maps were adapted from Taylor and Saloman (1969). The six major sediment types listed are portrayed by a series of graphic screens.

3.9 TIDAL CURRENTS

Tidal exchange is the major flushing agent in the Tampa Bay complex. River discharge, rainwater runoff, and sewage effluent discharge also contribute to localized flushing.

Daily tides in Tampa Bay are primarily semidiurnal (two high tides and two low tides). Tides follow the moon more closely than the sun, and each lunar or tidal day is about 50 min longer than the solar day. On certain days of the month, the tide becomes diurnal, and only one high and low tide occur during the period of a lunar day. Changes in wind and barometric pressure fluctuations cause variations in sea level from day to day. Strong southwesterly winds associated with low barometric pressure cause tide levels to increase above normal. Strong northeasterly winds, associated with high pressure, cause tide levels to decrease below normal.

Monthly mean sea level exhibits an annual cyclic pattern (see Figure 12). During February, sea level reaches its average annual minimum of 4.02 ft. During September, sea level reaches its average annual maximum of 4.67 ft. The numerical values of each tide height are referenced to the level of the primary bench mark for the St. Petersburg Municipal Pier NOS tide station (Hicks et al. 1983).




Figure 13. Mean annual St. Petersburg mean sea level, 1947 - 1980 (Hicks et al. 1983).

Sea level has been increasing slowly in Tampa Bay. The average increase in sea level in Tampa Bay is approximately 0.2 ft in a 34-year period or about 0.005 ft/yr (Hicks et al. 1983). A 34-year plot of the annual yearly means of sea level for the St. Petersburg Municipal Pier NOS tide station is shown in Figure 13. This trend in increasing sea level has been experienced at most NOS tide stations in the United States. Sea level has been increasing in San Francisco since 1855, when tidal records first began. National Ocean Service has found that sea levels have been increasing 0.009 ft/year in the northeast Atlantic coast, 0.005 ft/year in the gulf coast, 0.003 ft/year in the southwest Pacific coast, and decreasing 0.001 ft/year in the Pacific Northwest coast. The overall U.S. trend is for sea level to increase 0.004 ft/year (Hicks et al. 1983). Because of complex meteorological and oceanic interactions, future sea-level changes are not easily predicted.

Tidal currents result from water moving into Tampa Bay during flood tide and out of the bay during ebb tide. Slack tide occurs during periods of

reduced currents between flood and ebb tides. Residual tidal currents are produced by interactions between tidal currents and the bay bottom configuration. Residual currents create long-term water circulation patterns that control or significantly effect the distribution of dissolved and suspended constituents.




Figure 14. Typical flood tide current flow in Tampa Bay (adapted from Goodwin 1984).




Figure 15. Typical ebb tide current flow in Tampa Bay (adapted from Goodwin 1984).

Flood, ebb, and circulation patterns computed using a hydrodynamic model developed by the U.S. Geological Survey are shown in Figures 14, 15, and 16 (Goodwin 1984). Figure 15 depicts about 20 large and small circulation features (gyres) within Tampa Bay that are thought to control the rate of constituent flushing.

Residual tidal currents from this model are plotted on the individual 1:24,000-scale atlas maps. A detailed model study of computed particle dispersion done at the University of South Florida indicates that it takes 6 months to affect a 90% reduction in release particles within Tampa Bay. Particles dispersed in northern Old Tampa Bay may take as long as 20 months to be flushed from the bay (Wilkins 1983).

The resultant flows from the U.S. Geological Survey hydrodynamic model are plotted on the individual 1:24,000-scale atlas maps.

3.10 FRESHWATER-SALTWATER INTERFACE

Increased ground-water withdrawals from industrial, agricultural, and municipal ground water production fields have lowered the potentiometric surface (the level to which water will rise in a tightly cased well) in the Floridan aquifer. The Floridan aquifer is the principal ground-water source in the Tampa Bay study area.

Since freshwater is less dense than saltwater, freshwater from the Floridan aquifer floats on a saltwater wedge which underlies the Florida peninsula. In coastal portions of the Tampa Bay region, chloride concentrations range from less than 25 mg/l to 19,000 mg/l, forming a diffuse transition zone between saltwater and freshwater. Chloride (salt) ions are deposited from seawater moving inland from the neighboring Gulf of Mexico. Potential for saltwater intrusion is the greatest in the late spring (May). Water table levels and the potentiometric surface reach their annual lowest levels at this time, and the potential for saltwalter intrusion is greatest (Causseaux and Fretwell 1982).

For the purposes of this report, the 250 mg/l chloride concentration isopleth (line of equal chloride concentration) has been used to depict the 1979 position of the freshwater-saltwater interface in the Floridan aquifer on the individual atlas maps. A smaller scale version of this map is included in Figure 17.




Figure 16. Resultant current flow for one tidal cycle in Tampa Bay (adapted from Goodwin 1984).




Figure 17. Generalized position of the freshwater-saltwater interface in the upper portion of the Floridan aquifer across the Tampa Bay area (1979); 250 mg/l-chloride concentration isopleth, or contour line (Causseaux and Fretwell 1982).

- alimentary tract A tubular passage functioning in digestion and absorption of food.
- brackish Pertaining to a body of water whose salinity is between 0.5 and 30
 ppt.
- carnivore A meat-eating organism.
- crustacean An aquatic arthropod of the class Crustacea characteristically having a segmented body, a chitinous exoskeleton, and paired, jointed limbs. Examples include lobsters, crabs, shrimp, and barnacles.
- detritus Any particulate organic material derived from the process of decomposition.
- dinoflagellate Minute, chiefly marine unicellular algae of the order Dinoflagellata, characteristically have two flagella and a cellulose outer envelope.
- diurnal Lasting for one day.
- forage To search for food.
- gyre A circular or spiral system of movement, characteristic of oceanic currents.

ichthyofauna - Fish.

- isopleth Contour line connecting points of equal value of a given factor.
- invertebrate An animal species having no backbone or spinal column.
- metamorphosis Marked change in the structure of an animal during normal development, usually in the larval to adult stages. Examples include caterpillars changing into butterflies and tadpoles into frogs.
- morphological The structural makeup of organisms.
- omnivorous Pertaining to an organism which eats both plants and animals.
- pathogen Any agent that causes disease. Examples include viruses, bacteria, and fungi.

pelagic - Pertaining to organisms living in the open water.

phytoplankton - Minute, floating aquatic plants.

piscivorous - Pertaining to organisms that feed on fish.

planktivorous - Organisms feeding on plankton.

planktonic - Pertaining to free-floating microscopic organisms.

spawning - The process of releasing eggs or masses of eggs into the water. spit - A narrow point of land extending into a body of water.

toxin - A poisonous substance, usually having a protein structure, secreted by certain organisms.
