## PRIVATE LAND MOBILE RADIO SPECTRUM AUDIT DATA TO BECOME AVAILABLE IN ULS LICENSE AUDIT, BEGINNING JULY 28, 2004

As part of an ongoing effort to integrate license audit information into the Universal Licensing System (ULS), the Wireless Telecommunications Bureau (WTB) announces the integration of Private Land Mobile Radio (PLMR) Spectrum Audit data into the ULS License Audit database, effective July 28, 2004.

#### **Background**

The WTB conducted an audit of the construction and operational status of certain PLMR stations. The audit included most PLMR stations (radio services IG, YG, PW, YW) licensed on frequencies below 512 MHz that are subject to frequency coordination and rule-based construction and operational requirements. The PLMR Spectrum Audit resided in a separate database and will now be viewable with the results of the completed audit of the 220-222 MHz Commercial, site-specific licenses. The PLMR Spectrum Audit concluded with the release of a Public Notice<sup>2</sup> on June 8, 2004 and the update of ULS license records on June 10, 2004. #### **New Environment**

License Audit Search will be the tool for researching PLMR Spectrum Audit results. All of the current search capabilities for the PLMR Spectrum Audit will continue to be offered. Also, customers will be able to search by FCC Registration Number (FRN). Search results will display licensee name and address, reference number, audit letter date, call sign, radio service, responder, response, response date and cancellation date.

The following new capabilities and changes to the audit search will also go into effect:

- Only the most recent audit letter reference number will be viewable.
- Comments column will not be displayed in Audit Search.
- Ability to link to ULS License Detail, which now includes a history of audit correspondence (on the "Admin" tab).
