HIGHLIGHTS OF MELBOURNE-TITUSVILLE-PALM BAY, FL NATIONAL COMPENSATION SURVEY NOVEMBER 2003

Workers in the Melbourne-Titusville-Palm Bay metropolitan area averaged \$18.14 per hour during November 2003, according to a new survey released by the U.S. Department of Labor's Bureau of Labor Statistics (BLS). Regional Commissioner Janet S. Rankin reported that white-collar workers averaged \$20.82 per hour and accounted for 62 percent of the workers in the area. Blue-collar employees averaged \$14.37 per hour and represented 23 percent of the workforce, while the remainder worked in service occupations and earned \$12.62 per hour. (See table 1.)

The National Compensation Survey (NCS) presents straight-time earnings for occupations in establishments employing 50 or more workers in private industry and State and local governments. The survey excludes agricultural establishments, private households, the self-employed, and the Federal Government. This NCS covered 97 firms representing 84,300 workers in the Melbourne-Titusville-Palm Bay metropolitan area, which includes Brevard County in Florida. Seventy-eight percent of those represented worked in private industry.

In the Melbourne metropolitan area, average hourly wages were published for 14 detailed occupations. (See table 1.) Among white-collar workers, secretaries averaged \$13.50 per hour; general office clerks, \$12.51; and cashiers, \$7.96. Blue-collar occupations included truck drivers earning \$11.11 per hour and stock handlers and baggers at \$7.85. In the service occupations, public service police and detectives averaged \$17.40 per hour; and firefighting, \$15.27.

The NCS also provides broad coverage of selected occupational characteristics. (See tables 2 and 3.) For example, full-time employees in the Melbourne area averaged \$19.40 per hour and parttimers earned \$8.59. Union workers in blue-collar jobs averaged \$16.32 per hour, while their nonunion counterparts made \$14.08. Private industry workers at establishments employing 50-99 workers averaged \$10.86 per hour, while those in establishments with 500 or more employees earned \$23.37.

The NCS is part of a statistical program that has integrated three separate surveys of wages and benefits into one comprehensive compensation program increasing the amount of data available. Data provided by the NCS may be used by businesses for establishing pay plans, making decisions concerning plant relocation, and in collective bargaining negotiations. Individuals may use such data to help choose potential careers. Average rates of pay are also available for levels of work within an occupation based on knowledge, skill, independent judgement, supervision received, and other factors required on the job.
