CENTRAL PERSONNEL DATA FILE SUBMISSIONS

Agency Rankings are based on seven criteria.

Click on the criterion to see each agency's score.

1. DAYS TO SUBMIT

This measures how long it takes an agency to deliver an acceptable Status file to the Office of Personnel Management (OPM.) The measure is in calendar days, counting from the file "as of" date and ending on the date OPM receives the file. Scores of 30 and below are treated as 100 in computing the overall rating. Each day over 30 is one point subtracted from 100.

Expected Score: 30 or less

2. PERCENT OF STATUS RECORDS WITH VALID DATA IN CRITICAL FIELDS

This measures the Status file's minimum usability since critical fields are those used in most reports. The measure is a percent computed by dividing the number of records with valid data in all of the critical fields by the total number of records. Critical fields are defined in The Guide to the Central Personnel Data File Reporting Requirements.

Expected Score: 97

3. NUMBER OF DATA ELEMENTS VALID ON 99% OF THE STATUS RECORDS

This measures the Status file's quality by data element. The percent valid is computed by dividing the number of records with valid values by the total number of records. Scores of 50 are treated as 100. Lower scores are treated as a percentage of 50 depending on the file's date.

Expected Score: 50

4. PERCENT STATUS RECORDS WITHOUT ERRORS

This measures the Status file's quality by record. The measure is a percent computed by dividing the number of records with valid values in all fields by the total number of records.

Expected Score: 95

CENTRAL PERSONNEL DATA FILE SUBMISSIONS

5. PERCENT STATUS RECORDS COMPARED TO THE RECORDS REPORTED ON THE SF 113A
This measures the correspondence between the number of employees reported on two different agency submissions - the Central Personnel Data File and the SF 113A, "Monthly Report of Federal Civilian Employment." Figures from both sources are adjusted to minimize the differences caused by the differing reporting requirements. This measure is a percent computed by dividing the CPDF employment counts by the total employment line on the SF 113A.

Expected Score: 96

6. PERCENT TIMELY DYNAMICS RECORDS **(PLEASE NOTE CHANGE)**
This measures the timeliness of the records in the agency's Dynamics file. Records are timely if they have effective dates within one of the three monthly submissions for that calendar quarter. This is a change effective with June 2002. For March 2002 and earlier, a record had to be no more than 30 days prior to the ending date of the file's submission period to be counted as timely. Corrections and cancellations are excluded. The measure is a percent computed by dividing the number of timely records by the total number of records.

Expected Score: 90

7. PERCENT DYNAMICS RECORDS WITHOUT ERRORS
This measures the Dynamics file's quality by record. The measure is a percent computed by dividing the number of records with valid values in all fields by the total number of records.

Expected Score: 95
