INSTRUCTIONS FOR FORM U5A

1. Use of Form.

Rule 5A-3 prescribes the use of Form U5A, marked "adopted October 2, 1936," for notifications of registration filed with the Commission pursuant to Section 5(a) of the Public Utility Holding Company Act of 1935. Each holding company (other than one as to which an exemption is in effect) in a holding company system, should file a separate notification of registration. Any notification of registration may, however, incorporate by exact and specific reference any information or data contained in a notification of registration filed by any other holding company. Attention is called to the provisions of Sections 5(b) and 5(c) and the rules of the Commission thereunder with respect to the subsequent filing of a registration statement with the Commission.

2. Formal Requirements.

Each notification of registration shall be filed in triplicate. One copy shall be signed in the name of the holding company filing the same and shall be verified by the officer or agent who signs on its behalf. If the notification is signed by an agent or attorney, the power of attorney evidencing his power to sign shall be attached thereto unless it has been otherwise filed with the Commission. The other two copies may have facsimile or typed signatures and need not be verified. Notifications of registration should be on paper approximately 8.5" x 11" in size. The left margin should be at least 1.5" wide and the instrument should be firmly bound on the left side. The registrant should re-copy the entire form except the instructions, including the items in the form as well as the answers thereto. Such notifications of registration shall be delivered through the mails or otherwise to the Securities and Exchange Commission, Washington, D.C., and shall be deemed to have been filed with the Commission on the date when they are actually received by it.

3. Definitions.

As used in this form, the word "registrant" means the holding company filing the notification of registration. All other words and terms have the same meaning as in the Public Utility Holding Company Act of 1935 and the rules and regulations thereunder.
