



1. Q1. How long have you been a resident of Fulton County?




2. Q7. What type of water service do you use at this residence?




3. Q8. How satisfied are you with the quality of the water provided to your residence?




4. Q9. How satisfied are you with the amount of water provided to your residence?*




5. Q10. How often do you use bottled water for drinking/cooking in your home?




6. Q11. Why do you use bottled water in your home?

8. Q27. In your opinion, what effect does existing farmland have on the following for the area in and around Fulton County? (Numbers represent percent of responses)






10. Q29. How important is protecting farmland in Fulton County?*












14. Q50. Extent you encourage or discourage the clustering of houses in unincorporated areas?*



15. Q51. Extent you encourage or discourage the clustering of houses in cities and villages (incorporated areas)?*




16. Q52. To what extent would you support your county government protecting land by purchasing permanent development rights for land in Fulton County?*


