Report Highlights:

On September 29, 2003, the Department of Health, Ministry of Health and Family Welfare, Government of India (GOI) issued a Gazette notification under the Prevention of Food Adulteration Act (PFA), proposing additional pesticide tolerance levels on several crops, including crops of export interest to the United States, namely apples, grapes, wheat, peas, and soybean oil.

Introduction: This report summarizes a proposed draft amendment to the Prevention of Food Adulteration Rules framed under the Prevention of Food Adulteration Act (PFA), 1954, which sets additional pesticide tolerance limits on several crops, including apples, grapes, wheat, peas, and soybean oil, among other products.
