

# **AmeriCorps Program Receives Historic Funding Increase** Congress delivers on President Bush's Request to Expand AmeriCorps

> In addition to AmeriCorps, the bill provides funds for two other key programs of the Corporation: Senior Corps and Learn and Serve America. The Corporation's 2004 appropriation totals \$935 million - an almost 20% increase over the 2003 appropriation. Click here for details.

President Bush and I are grateful for volunteers across America for inspiring others to love their neighbors."

#### **\*** Mentoring

In honor of National Mentoring Month, President Bush invited two special guests to join him in the Capitol Building for his 2004 State of the Union Address: Jim Diesing and David Moreno, a "Big-Little match" with a Big Brothers Big Sisters chapter in Minnesota. Jim has been David's mentor for five years, and is the recipient of the 2003 Angel of Mentoring Award for Minnesota.

In the 2003 State of the Union Address, President Bush called for a three-year \$450 million initiative to recruit and train mentors for more than one million disadvantaged youth, with a special emphasis on children of prisoners. On January 22, 2004 Congress approved \$100 million of first year funding for this initiative. Grant competitions will be announced later this year.

#### **★** Citizen Corps

The Department of Homeland Security's Federal Emergency Management Agency has launched an on-line, independent study course for volunteer members of Community Emergency Response Teams. CERT members work with a community's emergency management officials to provide disaster assistance by helping victims, organizing spontaneous volunteers at a disaster site, and supporting emergency responders. #### **★** Learn and Serve America

\$3.2 million in grant funds is available from the Corporation for National & Community Service for organizations addressing homeland security concerns by engaging students in service-learning activities.
