Abstract receipt deadline for electronic submission: February 7, 2005 at 4:00 pm Eastern Standard Time.

ABSTRACT SUBMISSION PROCESS

ASGT will review all submitted abstracts and select abstracts for either oral or poster sessions. ASGT expects that all abstracts selected for presentation will be presented by the authors and that submitted abstracts will not be withdrawn. All accepted abstracts become the property of ASGT and will be published in *Molecular Therapy* and on the ASGT website. Please do not submit an abstract if you are not prepared to travel to the meeting and present it in the form selected by ASGT.

ELECTRONIC SUBMISSION

Please go directly to the ASGT website at www.asgt.org for complete instructions to begin the submission process. There is no fee for electronic abstract submissions.

ELIGIBILITY

Members of ASGT, as well as nonmembers, are eligible to submit abstracts. Submitting an abstract does <u>not</u> register you for the Annual Meeting. You must also register for the meeting. Meeting registration is available online at www.asgt.org.

PRIOR PUBLICATION

Papers that have been published prior to the time of presentation may not be submitted unless special consideration is requested. Special consideration may be requested by checking the appropriate box on the abstract form and providing a statement explaining the special circumstances.

REVIEW PROCESS

Abstracts will be peer-reviewed according to the subject category. Authors must indicate the review category (only one) during the electronic submission process. An abstract category must be selected before an abstract will be reviewed.

ABSTRACT PLACEMENT

The ASGT Program Committee will determine where abstracts will be placed within the program. All abstracts submitted will be considered for one presentation: either oral (simultaneous session) or poster.

TRAINEE TRAVEL GRANTS

ASGT will be offering a limited number of travel grants to postdoctoral fellows and students. The grants will be based on the highest abstract scores, as determined by the ASGT Abstract Review Committee.

The travel grants are worth up to \$500 for reimbursement for meeting-related expenses including lodging, travel and meals. To be considered for such a grant, please make sure to check one of the two boxes for Trainee Travel Award Consideration. Please note: Meeting registration fees are non-reimbursable; travel grant recipients must register for the meeting and pay the registration fees.

Work on vectors that illustrates basic principles of the vector system or is restricted to *in vitro* studies should be directed to categories A and B. Application of vectors in specific diseases or organ systems in animals or patients should be directed to category C.
