ENA Scholarships

Nurse in Washington Internship (NIWI) Program

Sponsored by the Nursing Organizations Alliance

APPLICATION DEADLINE: DECEMBER 1, 2004

The Nurse in Washington Internship program provides nurses the opportunity to learn how to influence health care through the legislative process. Participants learn from a distinguished faculty of health policy experts and government officials, many of whom are nurses. NIWI highlights include opportunities to network with other nurses, an Executive Branch briefing, and visits to Members of Congress.

This four-day (February 6-9, 2005) learning experience will energize and prepare attendees to become actively involved in the health policy process at the local, state or national levels. The Internship, in its 21st year, culminates with a day on Capitol Hill, when participants visit their legislators to discuss topics and issues of concern to them.

For 2005, the "early bird" registration fee for NIWI is \$675. Hotel accommodations through NIWI are \$179 per night single, \$199 double. Most meals are included with the Program. Transportation costs are paid by the participants.

ENA Scholarship Eligibility Requirements

- Two (2) \$1,800.00 scholarships are available for the 2005 NIWI Program. Applicants must be the current Chair or Chair-Elect of an ENA State Council/Chapter Government Affairs Committee.
- Applications (attached) must be received by Kathleen A. Ream, ENA Washington Representative, by December 1, 2004. Applicants are encouraged to E-mail (enagov@aol.com) or fax (703-534-9036) their applications.
- Handwritten or hand-printed applications will <u>not</u> be accepted.
- All blanks must be filled in. Attaching a curriculum vitae or resume in place of filling in blanks is **not acceptable**.
- Recipients will be notified by December 20, 2004.

Applications <u>not</u> meeting <u>all</u> of the above requirements will be ineligible for review.

Awarding of Scholarships

Applications will be reviewed by the National ENA Government Affairs Committee which will submit its recommendations to the ENA Board of Directors. The final decision is the Board's.

The criteria for determining awards are as follows, in descending priority:

- 1. Content/clarity of goal statement (50%)
- 2. Public policy involvement (30%)
- 3. Involvement in ENA (20%)
