

## NOMINATIONS FOR THE FSIS HOWARD E. BAUMAN AWARD

### **Introduction:**

The Food Safety and Inspection Service (FSIS) is soliciting nominations for the Howard E. Bauman award. The Howard E. Bauman Award was created to recognize an individual or individuals showing longstanding commitment, leadership and service to improving food safety. The award was first presented in 2002, posthumously, to Howard E. Bauman. Dr. Bauman is widely acknowledged as the father of the Hazard Analysis and Critical Control Point (HACCP) System for food safety process control. His daughters accepted the 2002 award on his behalf.

Nominations for the Howard E. Bauman award are not restricted to scientists. The Agency is interested in receiving nominations of persons from the broad food safety community who have positively affected food safety and public health. FSIS will accept nominations from the public for this non-monetary award through August 2nd.

### **Eligibility Criteria:**

- **Citizenship:** Any U.S. citizen or citizens may be nominated for the award.
- **Improving food safety:** The nominee's contributions have significantly improved food safety and public health, or have advanced the state of science toward that goal. The improvement need not be limited to the arena of meat, poultry, and egg products. The achievement is of service to everyday Americans, and can be described in terms meaningful to the lay person.
- **Longstanding commitment, leadership and service:** The nominee exercised leadership, overcame challenges, and collaborated with others to achieve the food safety improvement described above.
- **Length:** The narrative portion of the nomination should not exceed 2 pages. Please do not attach bibliographies, press releases, or other documentation.
- **Nominator:** Any person or organization may nominate an individual or individuals for the award. Nominations submitted by anonymous nominators will not be considered.

**Submission of Nominations:** Through August 2nd, nominations may be submitted to Sharin Sachs, Coordinator, Nominations Review Committee, by fax (202/205-0158); mail (Room 1166 South Building, FSIS, USDA, Washington, DC 20250) or hand-delivery (Room 1166 South Agriculture Building). Mailed nominations must be postmarked no later than August 2nd.

**Nomination Review Committee:** Nominations for the Howard E. Bauman award will be reviewed by a committee appointed by the Under Secretary for Food Safety and Administrator of the Food Safety and Inspection Service. The Nomination Review Committee will rank all nominations that meet the basic criteria. They will forward their recommendations to the Under Secretary and Administrator, who will make the final determination of the recipient of the Howard E. Bauman award.
